## Admissions Policy

An Ohio student need only have graduated from high school to be admitted to Wright State University. Students from out of state must, in addition, present evidence indicating better-than-average ability to do college work. No specific course of studies in high school is required. The American College Test (ACT) is required of all freshmen before they enter the university, not as an admissions test, but as information for advising and sectioning. Applications should be submitted during, but not before, the senior year in high school.

## University Library

The library resources center, currently housed on two floors of Millett Hall, has over 200,000 volumes and 3,200 periodicals, and a seating capacity of approximately 700 students. The library is a selective depository for state and federal government publications. Cooperative borrowing privileges exist with other state assisted universities in Ohio and with members of the Dayton-Miami Valley Consortium, thus expanding the resources available on the Wright State campus. The university also maintains the *Union List of Serials in the Libraries in the Miami Valley*, a list of journal and serial holdings of 44 area libraries.
