**Undergraduate Petitions Committee Minutes

On regular matters, the committee considered 34 student petitions from 7 entities.

Denied at college and university levels: 12

Approved at college level but reversed and denied at university level: 3

- CoLA: 1
- UC: 2

Denied at college level but reversed and approved at university level: 2

- CoLA: 1
- UC: 1

College and university levels both approved 2/3 of student's request but denied the other 1/3: 1

- CoLA: 1

College denied and student's request was specific to college requirements, so was listed as "for the record only" at university level: 1

- CoLA: 1

The meeting was adjourned at 11:40 a.m. The next regularly scheduled meeting is Friday, January 13 at 9:00 a.m.

The associated Refund Appeals Committee will next meet on Friday, December 2, for routine business.
