His interests are Education, Healthcare and International Affairs. Senator Strahorn has a daughter, Morgan Allison.

Dr. Hopkins reported that he and Provost Steven Angle are visiting with every college and updating them on the state budget. He also said that the Governor's office will not release the budget until the middle of March. A website will be unveiled today updating the news on the budget.

Admission applications are up 23% compared to last year's numbers. This just reinforces what we work so hard on is to be an affordable, high-quality institution.

Wright State University has recorded \$60,598,808* in external funding after the first six months of fiscal year 2010/2011. Recent awards include a \$343,627 award from the Ohio Department of Alcohol & Drug Addiction Services to Susan M. Fraker and JoAnn Ford to provide technology assisted care via e-therapy and other electronic means to enhance treatment for persons who experience substance use disorders and a co-existing disability. WSU also received an award of \$534,060 from the Leonard Wood Institute to Julie Skipper and Jennie J. Gallimore to develop and evaluate more realistic virtual humans and environments for effective cultural awareness training.

*FY11 awards include Federal Stimulus funding of State Share of Instructional (SSI) distribution. The SSI funding is not normally included in RSP figures and will be eliminated when the Stimulus program ends. Because these are federal pass through funds they must be accounted for on the A133 audit report and will, therefore, be included in the grant and contract award figures. Breakdown of the external funding figure noted above is as follows:



VIII. REPORTS OF THE COMMITTEES OF THE BOARD

A. Academic Affairs Committee

Dr. Joshi reported on the Academic Affairs committee meeting of January 21, 2011. The following topics were discussed:

• Provost Steven Angle's Report

Provost Steven Angle updated the Board on the various searches underway. The search for the dean of College of Science and Mathematics is underway with a list of 4 finalists to be interviewed the last half of February. Dr. Joshi is the Board representative on that search. Mr. Buddy LeTourneau from BLT Consulting has been hired as the search consultant for this search and also for the dean search in the College of Nursing and Health. The Lake Campus dean search will begin soon with Dr. Henry Limouze chairing that search. Lake Campus will use a search firm for this position. The process for the search for Dr. Matthew Filipic's replacement will begin this spring. Dr. Filipic will be retiring December 31, 2011.

Dr. Angle stated that negotiations with the AAUP (Faculty Union) are began January 21, 2011.

Provost Angle reported that last summer the campus partnered with Mr. Eric Ellis, of Integrity Development Corporation to help Wright State achieve an important part of our vision—to be known and admired for our diversity. A survey of campus climate was conducted last fall. As a result of the survey, we have engaged Dr. Jack Dustin and his team in the Center for Urban and Public Affairs to conduct focus groups the week of January 31st. Faculty, staff and students will be randomly selected by Dr. Dustin and his team to participate in the focus groups to assure diversity of representation. The results of the survey and focus groups will then be used to help develop a plan of action for campus diversity efforts.

Dr. Herb Dregalla, former chair of the Music Department, has been named coordinator of the semester conversion. This is a 2-year position.

1. Dean Emeritus Requests

B. Advancement Committee

Mr. Robert Nevin reported on the Advancement Committee meeting of January

Communications and Marketing Report

Mr. George Heddleston, associate vice president for Communications and Marketing, with the assistance of Jessie Sparks, web designer, reviewed new improvements to the Wright State website. The first improvement demonstrated was the new marketing plan, entitled *Changing Lives*. Web pages have been dedicated to the *Changing Lives* theme that includes alumni videos and ad media including billboards. In addition to the new theme, visitors to the home page are able to link to a beta test version of the new website. He encouraged everyone to visit the site and leave feedback. Lastly, Mr. Heddleston reviewed the Communications & Marketing newsroom website.

• Wright State University Foundation Report

Mr. Bob Batson, director of Advancement Services, stated that the portfolio for the Foundation returned 13.6% in the first six months of the fiscal year, which is slightly higher than its composite benchmark of 12.8%. The endowment portfolio market value continues to increase and is valued at \$70.5 million through December 31, 2010. Mr. Batson stated that the foundation's asset allocations have not changed, but the Board passed an investment policy statement that allows SEI to have more discretion on the margins of the active management of the portfolio. This allows for them to take advantage of short term efficiencies in the market.

Development Report

Ms. Rebecca Cole, interim vice president of University Advancement, introduced Ms. Jennifer McDonough, partner with Bentz Whaley Flessner, to the Board. Ms. McDonough has been retained as the campaign consultant. Possibly in March, Ms. McDonough will make a presentation to the full Board outlining the next comprehensive campaign. Ms. Cole stated that in the next couple of months, Ms. McDonough will be conducting a campaign study by interviewing Wright State alumni and friends. During the interviews, ideas about the campaign will be tested and participants will be asked for opinions about Wright State. All answers will be shared with leadership and the Board, but identities will be kept confidential. A campaign cabinet will also be established by April 2011.

Mr. Bill Shepard, assistant vice president for University Programs, provided an overview of the Reynolds and Reynolds check presentation to President Hopkins at the January 14th men's basketball game. The company provided a substantial gift for scholarships in hopes to recruit and keep talent in the Miami Valley. The fall appeal raised nearly \$50,000 with 500 donors, which is an increase from last year in both dollars raised and the number of donors (\$21,000 from 300 donors). The phonathon is doing well and has raised \$150,000 with 2,000 donors. Mr. Shepard shared the theme for the next faculty/staff CSIC campaign, which is entitled Race for the Future and is a play on the Amazing Race. Mr. Bill Shockley, executive director of Major Gifts, provided an update on the director of Major Gifts positions. stating that the department is fully staffed. In the last couple of months, the gift officers have been working with the deans and department chairs and analyzing relationships. Mr. Shockley stated that an alum of Wright State will visit campus on January 31 for what he describes as a WSU emersion. It is his hope that we can bring back more alumni for this kind of experience.

Alumni Relations Report

Ms. Cole reported that Ms. Susan Smith was hired as the interim executive director of Alumni Relations through August 2011. She will assist with the day-to-day operations and in the hiring of a permanent executive director for Alumni Relations. A couple of key events for the alumni office are the upcoming Reunion Weekend planned for February 4 and 5. She highlighted the Alumni Awards Brunch and encouraged attending this special event.

Advancement Division Update

Ms. Cole reported that the Wright State University Foundation Board of Trustees, with the leadership of Chair Christine Wallace, has a vision for the Board to improve the quality of life for the Wright State student. Ms. Cole also provided updates on the bond guarantee request for the Dayton Regional STEM School and an update on the request from the Wright State Physicians.

C. <u>Building and Grounds Committee</u>

Mr. Graber, chair, reported on the Building and Grounds Committee meeting of January 21, 2011.

- Dr. Robert Fyffe, professor and associate dean for Research Affairs, Boonshoft School of Medicine, reported on the plan to construct a new 64,000 square foot facility to be constructed within the biomedical and engineering research corridor on the Wright State University campus. This facility will provide interdisciplinary laboratories and shared core resources for more than 100 scientists, physicians, students, and post-doctoral researchers; offer convenient access to existing laboratories, equipment and university centers. In addition, the institute will address a significant need for improved access to neurological health care; support economic development and the creation of well-paying jobs; enable institute clinicians and researchers to conduct federally funded neuroscience research and clinical trials; and, gain visibility and recognition for institute partners and for the region as a whole.
- Dr. S. Narayanan, dean of the College of Engineering and Computer Science, spoke to the Trustees and the committee about the need to plan for a larger building to house a dynamic environment for collaborative education and research. Through the Engineering Collaboration Building on-campus and the WSRI Industrial Collaboration space off campus, they have an opportunity to leverage tremendous talent that exists within the university; enable growth of the Research Institute; and, transform the education they deliver, the research they conduct and the regional economic impact they can effect.
- Dr. Matt Rizki, Faculty Representative for the Building and Grounds committee, reported on the Faculty recommendations to the Master Plan. The Board appreciates the thorough, thoughtful comments from the Faculty and recognizes the leadership of Drs. Rizki, Krane and Bergdahl. The final draft of the plan will be presented at the March Building & Grounds Committee meeting and voted on by the WSU Board of Trustees at the April meeting.
- Dr. Robert Sweeney, executive vice president for Planning and secretary to the Board of Trustees provided an update on capital projects. He cited the funding priorities as being: classrooms and teaching space; the Schuster Concert Hall; the Student Union Renovation; the Rinzler Athletic Complex; the Neuroscience Building; and, the Engineering Collaboration Building.

D. <u>Finance and Audit Committee</u>

Mr. Klaben, chair, reported on the committee meeting of January 21, 2011.

- Dr. Howard Part, dean of the Boonshoft School of Medicine, presented a medical school update to the committee.
- Mr. Keith Ralston, associate vice president, Budget Planning and Resource Analysis, distributed the efficiency initiatives document. The efficiencies noted within the document are initiatives taken by the University and individual units that resulted in cost savings and cost avoidances. Additional efficiencies that generate new streams of revenue or increased productivity were also included in this document. This is the fourth year the state has required this report. It is the 7th year of a formal effort by Wright State. The calculated value of the efficiencies noted is \$17,060,002. This equals 6.7% of the university's operating budget. The state required a calculated amount equal to 3%.
- Mr. Ralston reported on expenditures greater than \$250,000 and less than \$500,000. No action was required on this matter.
- Mr. Jeff Ulliman, university controller, shared the university's investment reports for October, November 2010 and the December 2010 summary.

• Senior Vice President Filipic's Report

Dr. Matthew Filipic concluded with his vice president's report. Winter Quarter enrollments were strong, continuing the pattern of the past few years. Compared to Winter Quarter enrollments last year, both headcounts and credit hours were up 4.8%. We received an optimistic report on state revenues from the outgoing Strickland administration. If their predictions prove accurate, the state might be able to provide a greater portion of our June subsidy payment.

The Chancellor's recommendations regarding the priorities to be followed in the event of a hypothetical 90% budget contained some surprises. Most notably, he would eliminate need-based aid for public university students.

We are working with Huron on a project to make our budget allocations to colleges more responsive to the revenues they generate.

We are working with the IUC on a Shared Services project, but we are concerned that the data being generated by the various universities

may not be comparable. We are examining our ability to fund capital projects. We turned to an analysis we provided the committee in 2004. At that time, we had a steady level of state capital funding and a pattern of significant operating margins, a portion of which were available to fund additional capital work. Today's situation is much more uncertain. The state is now a year behind its normal schedule in adopting a new capital bill. We don't know if we will see a capital bill this year or if the state will simply miss a cycle. For a number of reasons (most notably the Great Recession), we have not enjoyed the same level of operating margins in the recent past. In addition future state operating funding is very uncertain. We hope we will have a better handle on state funding issues in March. That would allow us to determine our ability to go forward with some of the projects now in the pipeline.

E. Student Affairs Committee

Dr. Kunesh, chair, reported on the Student Affairs committee meeting of January 21, 2011.

• Vice President's Report

Dr. Dan Abrahamowicz, vice president for Student Affairs, gave an update on the progress of the Rinzler Student Athletic Complex. Incorporating the university master planning process and focused on the needs of students, Campus Recreation and Athletics; the project is in the final design phase.

Wright State's annual First Pitch Baseball Banquet was held on January 26, 2011 and featured a presentation by an executive with the Cincinnati Reds organization. This event is well attended and generates operating and scholarship dollars for the baseball program.

Parents' Weekend 2011 will be held on February 4-6th. Planned events include a Monte Carlo Night, Just for Parents presentation, WSU Men's Basketball game, 2010 Parent of the Year Award, and Breakfast with President David Hopkins.

The GLBTQA (Gay, Lesbian, Bi-Sexual, Transgender, Questioning, and Allies) Resource Room opened last week in the Student Union/Student Activities area with a welcome reception. Staffed by volunteers, the center will be open 40 hours weekly to serve students and the campus community.

The university chapter of Omicron Delta Kappa, the nation's most prestigious student leadership honorary, will be hosting the seventh annual Leader 2 Leader Conference on February 19th. Planned completely by students as an all campus event, the conference continues to be very popular.

• Student Government Report

Mr. Dan Thomas, Student Government President participated in the Ohio Student Government Association (OSGA) Conference and will be representing Wright State at the February 9, 2011 "OSGA Day" at the State House.

Student Government has several events planned to increase student participation at athletic events. The first "Organizational Challenge", a competition for student organization attendance at sporting events, proved very successful and will be repeated during winter quarter. The "Bus to Butler", an annual tradition, has again sold out with four busloads of students traveling to Indiana to watch the Men's Basketball game.

Student Government is developing plans for an ambassador program which would send students to area high schools to speak about Wright State. Collaboration with the University Center for International Education (UCIE) is underway to identify funding opportunities for students who lack the financial resources to participate in study abroad experiences.

Ms. Kelli Paul, the new Student Government Vice President, highlighted efforts to secure interdisciplinary funds for graduate student research projects and for travel support for students invited to present their research at conferences.

Updates

Student Ambassadors, Mr. Joel Parker and Ms. Megan Uhrig, outlined the history of the Wright State "President's Ambassadors" program and its value to the university and the student members themselves. Originally created during President Harley Flack's administration, the program was restarted in spring of 2009 to provide a strong student presence at university protocol events. Acting as greeters, tour guides, and good will ambassadors, the students personally benefit from opportunities to network and create connections with faculty, administrators, community leaders, and guests to our campus.

Mr. Dan Bertsos, director of Residence Services, gave an update on the Lake Campus housing project. Demand for on campus residential housing is high. As part of the Lake Campus Master Plan, funding has been secured from Peoples' Bank to begin construction of a 32 bed housing complex. Student applications for Phase I housing will be accepted beginning January 24th for a projected September 2, 2011 occupancy date. Should demand exceed Phase I capacity, Phase II (an additional 32 beds) will begin construction mid-March for a projected October 2011 completion.

• Enrollment Management Vice President's Report

Ms. Marian Hogue, University Registrar, discussed winter 2011 enrollment figures. Undergraduate headcount is 14,527 students, a 5.3% increase from winter 2010 and graduate headcount is 4,042, a 2.9% increase. Total unduplicated headcount (including School of Medicine students) is 18,569, a 4.8% increase from winter 2010. Fall 2011 applications are up by 22% (increase of 900).

Ms. Deanna McGrath, Systems Administrator in the Registrar's Office, demonstrated several of the new online registration services available to students via Wings Express. Students may now review a customized list of required and recommended textbooks for their specific courses and can order any or all of these textbooks online from the bookstore.

Students can also obtain an online enrollment verification certificate to document enrollment at the university. Another new service is the option to order and pay for an official transcript online. A new version of the degree audit software, interactive DARS, was also demonstrated. Students use DARS to track progress towards meeting degree requirements and can also do a 'what if' analysis to evaluate a potential change of major. These new degree audits use clear graphics to show completed and planned courses and run in seconds.

Ms. McGrath also demonstrated the faculty ability to enter final grades and view past grades online. A new service, Grade Change Workflow, allows faculty to submit grade changes online, automates the required approvals and provides an automatic notification to the student and instructor once the grade has been posted.

Ms. Hogue also discussed a new workflow module for Course/Program Inventory that provides faculty a streamlined way to submit and review

new course and program offerings. This module has been used extensively in the semester curriculum review and will continue to be used for course and program modifications in the future.

F. Student Trustees' Report

Mr. TJ Hufford gave a report on what comments the student body gave on the Wright State University Master Plan.

Students like:

- The connection being created between off campus and on campus housing. With the new housing and buildings that are being planned for in lot 4 and near University Hall and Rike, the University will move closer to its current housing and will begin to connect off campus housing, being used primarily by our students, to the rest of the University.
- The Creative Arts Center Quad and the outdoor theater. We feel like this will be a great addition to that east side of campus, while providing an added incentive for outdoor potential programming space.
- Adding the area of buildings connecting the Nutter Center to the rest of campus. By doing this we will be connecting ourselves to the Nutter Center, which, to many, isn't really a part of Wright State currently.
- Integrating the woods and improved landscaping into core campus. The students like this because it will provide more areas for comfortable leisure.
- The addition of parking garages and below ground parking structures. Due to the increased need for greater services and requirements for our diverse populations, including the community of disabled students, these covered parking structures are a necessity at this point.

Students dislike:

- The lack of a tunnel to the residential housing that will be replacing the current Forest Lane and Community Center building. If a tunnel system in this area is not possible, then maybe a sheltered walkway might be more feasible, and quite possibly more cost-effective as well.
- o The housing in the athletic core. We foresee many issues with this portion of the proposal. There will likely be a disconnect between those students and the rest of the residential students given that they will be separated by such distance and natural forest area. Given this, it would be the recommendation

of the students that this space be used for the possibility of new buildings, but to continue building housing extending the main campus to the current housing already in place.

The lack of additional programming space being allocated for student organizations and student life. We understand that the current master plan has the potential for a building to be constructed near University Hall that may move some current mainstay programming to this new building, and freeing up space in the student union for organizations and groups. We fully support this new building given the increased need for student programming space on campus.

G. <u>Faculty President's Report</u>

Dr. Jacqueline Bergdahl, Faculty President, gave today's report.

The Senate has been working on the Master Plan as reported earlier. They had an Adhoc Committee to increase the faculty input to the plan. The Adhoc Committee and the Building and Grounds Committee came up with a joint resolution on how to proceed. This resolution will be presented to the Board soon.

The Faculty Senate is working on the Faculty Constitution with just a few more issues to resolve before its completion.

The semester conversion is still moving along with 2,000 courses in inventory. She reported that they are completely through with many colleges and are in the process of thinking about modifications in the future.

function of their units; their shared history; elements of our partnership, institutional and informal; student learning; and, retention.
