Mr. Graber stated that the Wright State University Board of Trustees is a public body subject to the Ohio Open Meetings Act. It operates on a fixed agenda available to those attending the meeting. Persons wishing to address the Board in its Public Session should submit a written request to the Board of Trustees' office 72 hours in advance of the meeting in order to be placed on the agenda. However, all persons address the Board at the invitation of the Board and are subject to time limitations and other guidelines established to maintain the good order of the meeting.

## **VII. REPORT OF THE PRESIDENT**

### **A. University Update**

President Hopkins provided an update on selected university activities.

- Spring enrollment increased by 4% in comparison to last year at this time.
- Lake Campus had their first Lake Campus Regional Summit on Friday, March 25<sup>th</sup>.
- Wright State has identified 7 Centers of Excellence within our institution and 6 of those Centers have been identified by the state of Ohio.
- Wright State will host the 2013 National Science Olympiad. The first invitational was held on Saturday, February 26<sup>th</sup> with over 1,200 students attending.
- One of Wright State's Alumni, Dr. Michael Barratt was on the 39<sup>th</sup> and final mission for Space Shuttle Discovery in February 2011.
- The 12<sup>th</sup> Annual ArtsGala will be held on campus on Saturday, April 2<sup>nd</sup>.
- The International Friendship Affair will be held on Saturday, April 16<sup>th</sup> in the Student Union Apollo Room. For two decades, Wright State university, through the University Center for International Education has hosted a wonderful event at which all WSU students, as well as the Dayton area community have had the opportunity to learn about aspects of the culture and heritage of the Wright State international student body.

**B. Honorary Degree Nomination – Doreen Mogavero**

The Honorary Degree Subcommittee of the University Commencement Committee invited nominations for honorary degrees. The committee submitted a recommendation to the President, with the final decision to be made by the Board of Trustees. The following resolution was approved by the Board.

**RESOLUTION 11-27**

WHEREAS, Wright State University established in 1976 a process by which individuals of outstanding achievement may be honored by the university to recognize constructive value to the university and society; and

WHEREAS, the Honorary Degree Subcommittee and the Academic Affairs Committee have received and affirmed the recommendation to award honorary degrees during the spring 2011 commencement ceremony; and

WHEREAS, honorary degrees are to be given for outstanding individual contributions and service; and

WHEREAS, the committees have accepted the nomination of Doreen Mogavero, president, CEO, and lead broker of Mogavero, Lee & Co.; and

WHEREAS, Doreen Mogavero has created a successful 36-year career at the New York

Stock Exchange, becoming the youngest member on the floor in 1980, at the age of 25; and

WHEREAS, she founded Mogavero, Lee & Co., the first and only floor-based, direct-access firm to be wholly owned and operated by women; and

WHEREAS, she was the only woman working on the floor who owned her own seat when the New York Stock Exchange Group went public; and

WHEREAS, she was the first woman from the floor to be appointed to the New York Stock Exchange Board of Executives; and

WHEREAS, she was the first woman to chair the Market Performance Committee; and

WHEREAS, Doreen Mogavero has established a close relationship with faculty and students in the Department of Finance and Financial Services in Wright State University's Raj Soin College of Business; and

WHEREAS, she has made outstanding accomplishments in a historically male-dominated field, Doreen Mogavero serves as a role model to Wright State students facing obstacles to achieving their dreams; and

WHEREAS, Doreen Mogavero is dedicated to the mission of Wright State University and the education of our students; be it therefore

RESOLVED that the Wright State University Board of Trustees hereby approves the granting of the Doctor of Humane Letters degree to Doreen Mogavero; and be it

RESOLVED that this degree be conferred upon Doreen Mogavero at the June 11, 2011, commencement ceremony.

#### **D. Report of Investments**

Since the last Board meeting, investments for December 2010 and January 2011 have been received. This report has been distributed to the trustees and is filed with the official Board of Trustees' records.

#### **E. Ratification of Contracts and Grants**

Wright State University has recorded \$79,222,416\* in external funding for 462 awards for the time period of July 1, 2010 through February 28, 2011. Recent awards include a contract incrementally funded in the amount of \$500,000 for "Neuroscience and Medical Imaging" from the U. S. Air Force Research Laboratory to Dr. Sundaram Narayanan, Dr. Julie Skipper, Phani Kidambi, Dr. Kevin Bennett, and Dr. Ping He to support the Air Force's evolving Air, Space, and Cyberspace mission by enhancing cognitive assessment techniques, developing and transitioning computational cognitive models, and refining techniques for cognitive performance enhancement. (Total award over five year period is projected to be \$4,997,167.)

\*FY11 awards include Federal Stimulus funding of State Share of Instructional (SSI) distribution. The SSI funding is not normally included in RSP figures and will be eliminated when the Stimulus program ends. Because these are federal pass through funds they must be accounted for on the A133 audit report and will, therefore, be included in the grant and contract award figures. Breakdown of the

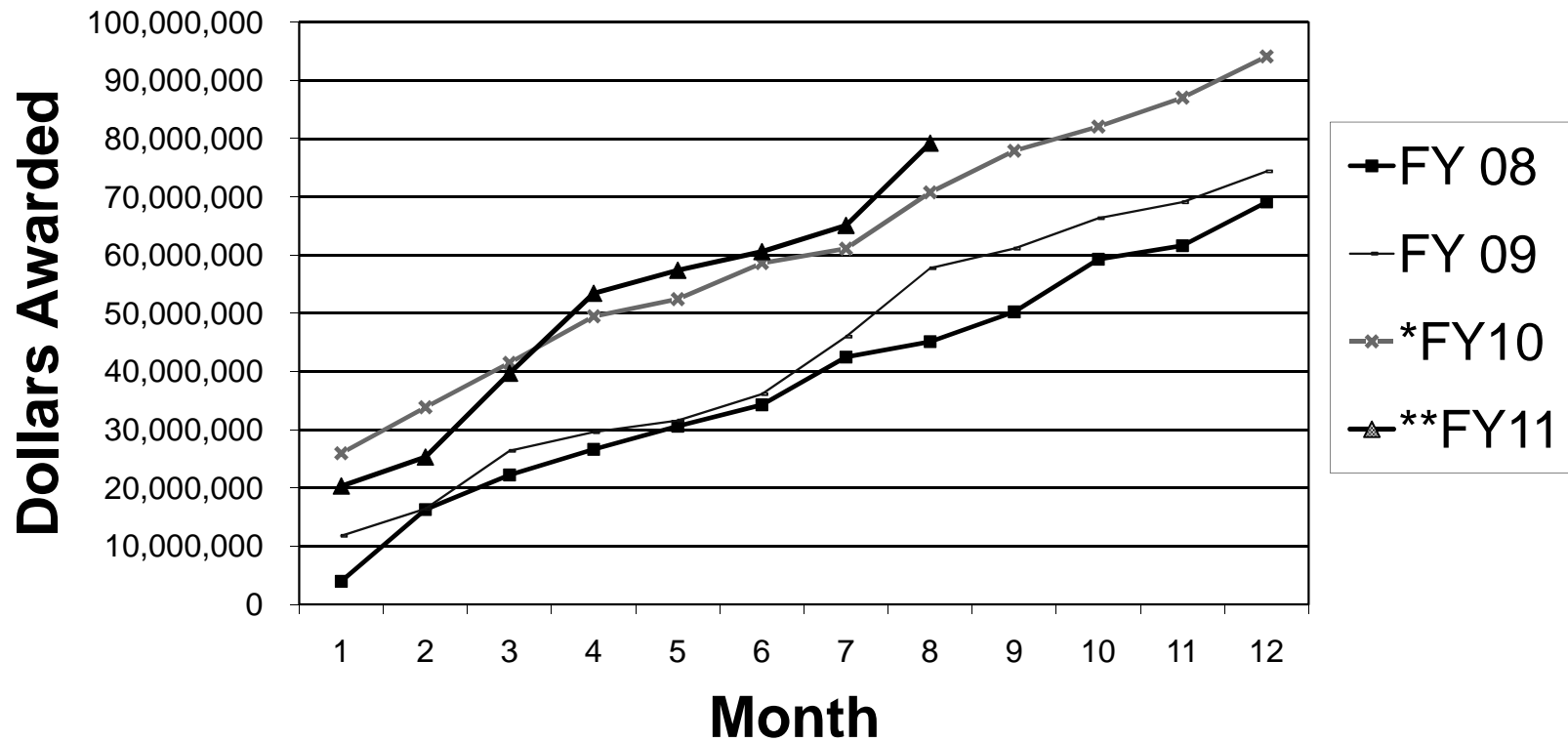

## **VIII. REPORTS OF THE COMMITTEES OF THE BOARD**

### **A. Academic Affairs Committee**

Dr. Nina Joshi, chair, reported on the Academic Affairs committee meeting of March 18, 2011. The following topics were discussed:

- **Provost Steven Angle's Report**

Dr. Angle commented on the four leadership searches that are currently underway:

- Science and Mathematics – Four candidates have been interviewed on campus. Feedback has been received and Drs. Hopkins and Angle will meet with the chair of the committee next week; a decision is forthcoming.
- College of Nursing and Health – Ads have been placed. Mr. Buddy Tourneau, the search consultant we have been working with, has several strong candidates. First review is scheduled for the end of March.
- Lake Campus – Search to move forward soon.
- Vice President for Business and Finance search will begin shortly with Mr. Vishal Soin as the WSU Board of Trustee representative.

The University Promotion and Tenure Committee met on March 7, 2011 and 50 recommendations for promotion and/or tenure was shared in the President's Report for approval at the June 10<sup>th</sup> meeting of the Board of Trustees.

Two Wright State University faculty members were among 16 statewide to be honored for innovative practices that saved students money on textbooks:

- Dr. Shu Schiller, assistant professor, Information Systems and Operations Management, Raj Soin College of Business
- Dr. Anand Jeyaraj, assistant professor, Information Systems and Operations Management, Raj Soin College of Business

The annual awards recognize University System of Ohio faculty or faculty teams that have found creative ways to reduce the cost of course materials for their students while also improving educational content.

ArtsGala is scheduled for April 2<sup>nd</sup>, 6:30 p.m. to Midnight in the Wright State University's Creative Arts Center. An evening of music, theatre, art, themed dining rooms and a silent auction is scheduled.

The Celebration of Research, Scholarship and Creative Activities is a salute to the scholarly explorations of WSU undergraduate and graduate students. This is scheduled for April 8, 8:30 a.m. – 5 p.m. in the Apollo Room.

The Open House and Reception for the National Center for Medical Readiness at Calamityville's new Learning Center has been confirmed for May 6<sup>th</sup>.

- **Institutional Accountability Report for University System of Ohio Strategic Plan**

Dr. Angle provided a draft of the Institutional Accountability Report for the University System of Ohio Strategic Plan. This is a set of 20 metrics produced by USO to measure the success of the following goals: access, quality, affordability and efficiency, and economic leadership.

- **Collective Bargaining and Senate Bill 5**

Dr. Henry Limouze, associate provost for Faculty and Staff Affairs, updated the committee on the collective bargaining negotiations and Senate Bill 5. Senate Bill 5 is a bill and not a law so Dr. Limouze has been negotiating in good faith with the AAUP on the contract, which is due to expire on June 30, 2011.

- **Semester Conversion**

Dr. Herb Dregalla, director of Semester Conversion, reported that the Steering Committee Transition Team meeting was held March 17<sup>th</sup>. Dr. Larry Ream, chair of the Policies Committee of the School of Graduate Studies, reported that as of March 17<sup>th</sup> there have been 1,627 courses approved and only 28 courses remaining in the system. There are 161 programs approved and none in the system. Undergraduate programs are not quite up to date, but as of March 14<sup>th</sup> there are 1,817 courses approved with 29 courses in progress; 159 programs approved with 20 in progress. The conversion appears to be on schedule.

## **B. Advancement Committee**

Mr. Fred Strahorn reported on the committee meeting of March 18, 2011.

- **Wright State University Foundation Report**

Mr. Bob Batson, director of Advancement Services, stated that the portfolio returned 15.3% through January 31, 2011, which is favorably higher than its composite benchmark of 14.2%. The endowment portfolio market value continues to increase and is valued at \$71.1 million through the end of January. Mr. Batson stated that investment earnings have also had a positive effect on the Foundation's unrestricted net assets. The reserve has nearly doubled since the beginning of the fiscal year and ended January with a value of nearly \$3.6 million. The budgeted expenses were only 41% spent at the end of January with no unanticipated variances.

Mr. Batson reported that the Foundation provided financial guaranties on two capital projects undertaken by organizations related to the mission of the university. In the first instance, the Foundation pledged its unrestricted net assets as a partial guaranty of bonds issued to purchase and renovate a building that will be utilized by the Dayton Regional STEM School. The second project involves the construction of a new medical office building on the WSU campus, a project initiated by Wright State Physicians. This guaranty pledges the net assets of several Boonshoft School of Medicine funds in an amount equal to the bonds issued to finance construction.

- **Communications and Marketing Report**

Mr. George Heddlestone, associate vice president for Communications and Marketing, stated that Wright State University was designated "a high research activity university" by the Carnegie Foundation for the Advancement of Teaching. This designation will be incorporated into printed and written materials. Two members of the Communications and Marketing staff were honored with 2011 Hermes awards by the American Advertising Federation's Dayton Chapter. The honorees were Mr. Will Jones, senior photographer, and Ms. Karen Strider-liames, director of Brand Development.

Mr. Heddleston reported that two current Wright State employees joined the Communications and Marketing staff to lead construction of the university's first Content Management System for the wright.edu website. The spring issue of *Community* magazine will be available in May and will feature prominent Wright State families.

- **Development Report**

Ms. Rebecca Cole, vice president for Advancement, reported that an internal solicitation of university leadership is underway. Individuals are being asked to consider a multiple-year pledge to the campaign that hopefully will net us leadership gifts from this group. Ms. Cole and her team are working on the Benjamin and Marian Schuster Hall project which is a \$4.2 million project. Ms. Cole stated that approximately \$3 million has been raised. We are reaching out to the Mayerson Foundation in Cincinnati. Ms. Marian Schuster's maiden name was Mayerson, and her brother is the President of this foundation. Ms. Cole has asked for a lead gift to finish this campaign.

We are having early conversations with the Foundation Board members about their gifts to the campaign and also the Board has never really had a giving expectation. We started with establishing the first Foundation Board scholarship. We were successful in raising enough so that every college, school, and the Lake Campus will receive approximately a \$3,500 - \$4,000 cash award. The comprehensive campaign total is at \$33,982,760. We are working with a gift pyramid with the goal to be determined.

The Campaign Planning Study has begun with letters of invitation being mailed to 66 alumni, friends, and donors inviting them to participate in the study. Interviews conducted by our campaign consultant will begin on March 24<sup>th</sup> and run through early May. The results of the study will be provided to the members of the University and Foundation Boards and to the members of the Campaign Cabinet.

Ms. Cole stated that the gift acceptance policies have been updated to make them current with best practices and to serve the anticipated increase in gift activity relative to the campaign. Mr. Regis Lekan reviewed the policy for the Board members and the changes that were made.

- **Alumni Relations Report**

Ms. Cole reported that Ms. Susan Smith, executive director of Alumni Relations, along with President David Hopkins entertained 80 alumni in New York City. Alumni Awards will be May 20<sup>th</sup>. Nominations are now being taken for the Alumni Achievement Awards. These awards are given in three categories: Recent Graduate Achievement, Volunteer Achievement and the Distinguished Alumni Achievement. Recipients of these awards are chosen by the Alumni Association's executive committee. The Alumni Reunion Weekend held on February 4 and 5<sup>th</sup> was very successful. 2011 marked the fourth year for the weekend and there was record attendance at each of the events.

**C. Building and Grounds Committee**

Dr. Kulkarni reported on the Building and Grounds Committee meeting of March 18, 2011.

- Dr. Robert J. Sweeney, executive vice president for Planning and secretary to the Board of Trustees, discussed the Campus Master Plan and what has been defined as Phase 1 priorities. With the semester conversion coming in the Fall of 2012 he proposed a new classroom building. The second priority would be for the Student Union to be renovated to a one-stop shop for students. The third priority is the Schuster Concert Hall. We have a named gift in hand and have been invited to apply for additional grant dollars. The Rinzler Sports Complex will soon be under construction. Other priorities include the completion of the Raider Road Extension, acquisition of University Park, and the construction of the Neuroscience Building. Dr. Sweeney reviewed other priorities including a CAC parking garage, a Creative Arts Center Complex, and the Engineering Collaboration Building. Some other items that are off line but still important in Phase 1 of the Master Plan is the Wright State Physicians Building, the Wright State Research Institute, the Nutter Center Lake and the Diocese Property.
- Ms. Vicky Davidson, associate vice president, Facilities Planning and Development, informed the Board that the Boonshoft School of Medicine is considering expanding their simulation labs and several training centers.

- Dr. Matt Rizki, faculty senate representative, commented on the Master Plan, stating that the Senate has strongly endorsed building classrooms and feels, in regards to the parking garage, it would be better to be cautious.
- Mr. Dan Papay, university engineer, updated the Board stating that 3 miles of Wright State University's water main is 40 years old and is in need of repair or replacement. Last October a civil engineer was hired to assess the situation. Mr. Papay looked into the idea of going on Fairborn's water system, but Wright State would have to repipe anyway. Mr. Papay said that they were in the design development stage with starting work this summer. The cost is estimated at \$2 - \$2.4 million.

#### **D. Finance and Audit Committee**

Mr. Larry Klaben, chair, reported on the committee meeting of March 18, 2011.

- Mr. Jason Kezelman, vice president/account manager of PIMCO, distributed handouts and gave a detailed update on WSU's investment performance.
- Mr. Rocky Doering, vice president/consultant of Fund Evaluation Group, provided a report on our investment performance in 2010. He also reviewed an update through February 2011.
- Mr. John Curry, managing director of the Huron Consulting Group, reviewed the university's engagement with Huron Consulting, evaluating new incentive based budget options.
- Mr. Paul Hernandez, director of Computing & Telecommunications Services reported on the new technologies that have been put in place in CaTS. He also reported on some of the initiatives that Wright State is involved with other universities (Miami University, Ohio State and Ohio University among others).
- Dr. Matt Filipic, senior vice president for Business and Fiscal Affairs, updated the committee on the FY 2010 Senate Bill 6. The new report from the OBR shows the fiscal 2010 Senate Bill 6 calculations. The state developed this system in the late 90's for quantifying a judgment about the finances of each the state colleges and universities. It is driven by three ratios – viability ratio,

primary reserve ratio, and net income ratio. These three ratios are weighted. This year our composite score rose to 4.1.

**2. Change in Bid Limits Resolution**

**RESOLUTION 11-31**

WHEREAS, the Board of Trustees approved a bid limit for construction projects of \$25,000 in Resolution 98-38, approved in February 1998; and

WHEREAS, the state of Ohio has a bid limit for construction projects of \$50,000; and

WHEREAS, the state of Ohio must approve our construction expenditures when they are state funded; and

WHEREAS, the difference between state and university bid limits on the same project is a source of confusion; and

WHEREAS, a survey of other Ohio public universities reveals that ten of the thirteen have bid limits of \$50,000 or higher for construction; therefore be it

RESOLVED, that the Board of Regents hereby revises purchasing policy to require that construction work shall be purchased through selection of competitive bids or proposals except when the amount is less than \$50,000.

Dr. Kunesh moved for approval. Mr. Strahorn seconded, and the motion was unanimously approved by roll call vote.

- Mr. Ralston reviewed the university's expenditures of \$250,000-\$499,999. No action was required.
- **Senior Vice President Report**

Dr. Matt Filipic concluded with his report.

Revenue news is positive. Enrollments, which have been substantially above estimates all year, appear to be strong again for Spring Quarter. The additional tuition income will help us deal with the challenges posed by the state budget. In addition, we are now being told that state tax revenues are strong enough to permit the state to make a full June payment, which had been called into question last September.

The Governor's budget proposals became public on Tuesday. The proposed cuts to higher education were simultaneously the worst we have ever seen and significantly less than we had feared. We don't know the specific implications for us yet, but it seems that the Governor's proposed cuts can be absorbed with a manageable round of cuts to our budget, given the steps we had taken to prepare. The budget bill will apparently include significant construction reform, a shift in responsibility for funding retirement costs (two percent of payroll now being paid by employers will shift to employees), and perhaps other regulatory relief as well. It appears that there will be no capital bill this cycle.

Accenture is preparing a proposal for shared services to be reviewed by the university presidents in April. We believe the proposal will call for a five year effort that will begin with an effort to have campuses adopt common business practices that would make later centralization more feasible.



We have a new Chancellor this week: Jim Petro, who has a long record of elected service in Ohio including terms as Auditor of State and Attorney General.

We are negotiating our electricity rates with DP&L.

Dr. Filipic closed with a review of the management improvements to our campus printing operation, now headed by Mr. Pat Bruchs. There has been a wide range of improvements in service, cost containment, and revenue enhancement in the past two years

#### **E. Student Affairs Committee**

Dr. Kunesh, chair, reported on the committee meeting of March 18, 2011.

- **Vice President's Report**

Dr. Dan Abrahamowicz, vice president for Student Affairs, discussed the Fall 2011 opening of three new living/learning communities in student housing. Residence Services has set aside a floor in the Woods community for Sports Medicine majors to live together and another for Latino students. Also, Residence Services is collaborating with Montgomery County Children's Services, to offer a living/learning community to assist students transitioning from foster care to independent living.

Campus Recreation is working with university planners to expand the Fitness Center to incorporate an additional 1,000 sq. ft. of recreational space in the facility to ease crowding and meet increased demand.

In February, Career Services hosted three Career Fairs attended by 999 Wright State students and alumni. These events had strong participation with 378 employers available to meet with students. In addition, during Winter quarter, 297 individual student interviews were conducted directly on campus.

Ms. Tonya Mathis, associate director for Student Activities, and Mr. Davy Fogler, student president of the University Activities Board (UAB) highlighted some of the accomplishments of UAB. Known as the "Premier Student Programming Board", UAB has responsibility for many well attended events including Metro Nights, Fall Fest and May Daze. As part of their concert series, UAB was successful in booking Ke\$ha, a nationally recognized pop singer, for a "sold out"

Wright State Nutter Center concert in April.

- **Faculty Senate**

Dr. Dan Krane, professor of Biological Sciences, president elect of the Faculty Senate and chair of the Athletic Council, discussed some of the initiatives instituted by the Athletic Council to engage the faculty with Wright State Athletics. The successful “Blackboard to Backboard Challenge” was created to increase student attendance at basketball games and the “Pre Game Lecture Series” offered game attendees a 30-40 minute presentation on academic research being conducted on campus.

The Faculty Senate continues to address the challenges involved with converting from quarters to semesters and is evaluating various Faculty Senate committees in an effort to channel the best resources behind the most challenging issues.

- **Updates**

Mr. Gary Dickstein, assistant vice president for Student Affairs and director of Community Standards and Student Conduct, and Dr. Bob Rando, director of Counseling and Wellness, discussed the focus of the Student Concerns Committee. The committee’s mission is to: 1) identify, assess and respond to situations with troubled students that pose a significant threat to the safety of the campus community, and 2) work with students to provide support and services.

Working as a resource team, the Student Concerns Committee offers a high level, coordinated assessment from various campus faculty and staff to respond to, and help, students in crisis. The goal is to provide the highest possibility of success for the student while maintaining the safety and security of the campus community.

- **Enrollment Management Vice President’s Report**

Ms. Cathy Davis, assistant vice president for Undergraduate Admissions, discussed student interest in attending Wright State. Demand remains strong as evidenced by increased student attendance at the recent Spring Open House (100 additional students over last year’s). As of March 14<sup>th</sup>, there has also been a

significant increase in undergraduate applications. The “Direct from High School” applications were up by 1,000 (or 16%); the number of transfer applications increased by 250 (or 43%) and the total number of applications were up by 1,400 (or 21%) over last year.

With recent budget deficits, state and federal governments are reducing or eliminating grants to low income students. Ms. Jennifer Penick, director of Financial Aid, outlined the challenges facing Wright State in determining student financial aid packages when traditional grant funding sources are eliminated, guidelines for awarding aid are under revision, and expected award amounts have not yet been determined.

Ms. Nadine Brown, assistant vice president for Enrollment Marketing and Services, and Mr. John Rogers, director of Orientation and First Weekend, gave an overview of “Orientation 2011”.

Based on student feedback, our direct from high school student 2011 Orientation will continue as a half-day program that focuses on the "Essentials": important tasks a student needs to complete prior to attending Wright State University. Activities include: personal academic advising with college and/or university college advisors, student led presentations, and interaction with upper class student orientation team leaders.

Orientation 2011 students will have earlier access to registration. They will be further engaged through multimedia resources such as Facebook, and new for this year a fun and engaging video (using Youtube) which was developed so that students understand “What to expect at Orientation” prior to their arrival. The lead actors are ROWDY and two student Orientation team leaders, Brittney Fultz and Robert Johnson.

The day of Orientation, students will also be able to participate in optional afternoon activities that will provide them with information regarding financial aid, student life, campus safety, move-in day and much more.

For our UCIE students, an interactive online Orientation magazine was created to introduce and to acclimate our international students to Wright State University and the Dayton area prior to arrival in the United States. This is offered in four languages; Arabic, Chinese, Korean and English.

## **F. Student Trustees' Report**

Mr. Timothy McEwen, student trustee, gave today's report:

- Student Government has recognized how important the Student Abroad program is at Wright State and took some steps to make the program more affordable and accessible to many students including disabled students. One option is to create a fund to offset the cost for special needs to disabled students as well as students who need help with the cost of the program.
- Kelli Paul and Matt Conaway from Student Government have worked on a number of initiatives to increase security on campus due to the sudden number of reported crimes on campus. This included a sexual assault awareness panel and a women's self-defense workshop. Student Government has taken a move to make this campus more sustainable. As part of that endeavor they have become a part of recycle mania, which is a nationwide competition among universities to see which university can recycle the most. Student Government has accepted the Master Plan especially regarding the easement through the university woods with the recommendation that no further cutting into the woods go forth. Student Government is currently in beta testing of a new social website that will be referred to as Raider Comments. A student organization semester transition program has been established to help student organizations adapt to the semester conversion.

## **G. Faculty President's Report**

Dr. Jacqueline Bergdahl, Faculty President, was unable to attend the meeting. She sent a written report that was read in her absence.

The updated Faculty Constitution was approved by the Faculty Senate on February 7<sup>th</sup> and will be put up for ratification by faculty spring quarter. It is slated to go into effect September 1, 2011 if ratified.

Semester course numbering took a lot of discussion in our last meeting, but it appears to be resolved.

We saw a lot of semester conversion activity. That process is ongoing.

The Faculty Senate Executive Committee asked the semester director to

reconsider the semester time block in light of classroom space concerns and to make recommendations to the Faculty Senate.

Faculty President-Elect nominations are being accepted until April 18<sup>th</sup>.
