Wright State University ended its fiscal year 2011 with a total of \$86,085,644 in external funding representing 600 awards (not including SSI Stimulus Subsidy). For the period of July 1-August 31, 2011 the University recorded 161 awards for a total of \$34,099,544.


Recently funded projects include a \$400,004 CAREER award from the National Science Foundation (NSF) to Dr. Haibo Dong (Mechanical & Materials Engineering) to advance the fundamental knowledge of biological fluid dynamics in nature through an integrated computational and experimental approach. Another recent award from NSF in the amount of \$480,000 to Drs. Amit Sheth (Computer Science & Engineering), Valerie Shalin (Psychology), and John Flach (Psychology) will support an examination of how organizations can effectively utilize and respond to user involvement and communication medium made possible by new forms of social media. And, from Ohio, a grant in the amount of \$959,570 from the Department of Development was given to support Dr. S. Narayanan (College of Engineering & Computer Science), Dr. Thomas Hangartner (Biomedical, Industrial, and Human Factors Engineering), and Dr. Jennie Gallimore (Biomedical, Industrial, and Human Factors Engineering), Mr. Aaron Miller (Wright State Research Institute), and Dr. Mark Gebhart (Community Health) as they establish the Human Performance Center of Excellence. The goal of the endeavor is to build a nationally recognized research center for the Air Force, Dayton region, and the state of Ohio focused on advancing human performance technologies through research, development, training, and commercialization.

A resolution authorizing the issuance of general receipts bonds of Wright State University, in one or more series, in a maximum aggregate principal amount not to exceed \$63,000,000 to (i) pay costs of construction of a new classroom building, renovations of existing classrooms, replacing the main water lines, renovating the Student Union, renovating the concert hall, improving and adding outdoor student recreation space, acquiring a new building or buildings for research and administrative uses, constructing a new academic or research building, expanding the Creative Arts Center, replacement of the Nutter Center scoreboard, constructing parking lots, and acquiring additional real estate, together with all necessary appurtenances thereto, (ii) advance refund certain outstanding general receipts bonds to achieve savings and (iii) pay costs of the issuance of the bonds; authorizing a fourth supplemental trust agreement; and authorizing related documents.

### **RESOLUTION 12-13**

WHEREAS, pursuant to Ohio Revised Code Sections 3345.07, 3345.11 and 3345.12 (the "Act"), as enacted under authority of the Ohio Constitution, and particularly Section 2i of Article VIII of the Ohio Constitution, Wright State University, a state university of the State of Ohio created and existing pursuant to Chapter 3352 of the Revised Code, is authorized and empowered, among other things, to (a) issue Obligations of the University to pay the Costs of Facilities and to refund Obligations of the University previously issued to pay Costs of Facilities; (b) pledge to the payment of those Obligations the gross amount of the General Receipts of the University in priority to all other expenses, claims or payments; (c) covenant that the University will make, fix, adjust and collect the fees, rates, rentals, charges and other

items comprising General Receipts to produce General Receipts sufficient at all times to meet requirements with respect to the Obligations; and (d) provide for a trust agreement and make further provisions for securing the payment of the Obligations, all as defined below; and

WHEREAS, on March 13, 2003 this Board adopted its Resolution No. 03-20 (the "General Bond Resolution") which authorized the issuance from time to time of General Receipts Bonds of the University, with each issue to be authorized by a resolution of this Board pursuant to the trust agreement authorized by the General Bond Resolution; and

WHEREAS, pursuant to Resolution No. 03-21 adopted by this Board on March 13, 2003, the University issued \$16,925,000 General Receipts Bonds, Series 2003 (the "Series 2003 Bonds") pursuant to a Trust Agreement dated as of March 15, 2003 (the "Original Trust Agreement"), as amended by a First Supplemental Trust Agreement dated as of March 15, 2003 (the "First Supplemental Trust Agreement"); and

WHEREAS, pursuant to Resolution No. 05-17 adopted by this Board on November 19, 2004, the University issued its \$31,335,000 General Receipts Bonds, Series 2004 (the "Series 2004 Bonds") pursuant to a Second Supplemental Trust Agreement dated as of December 1, 2004 (the "Second Supplemental Trust Agreement"); and

WHEREAS, pursuant to Resolution No. 10-9 adopted by this Board on November 6, 2009, the University issued its \$11,420,000 General Receipts Bonds, Series 2009 (Federally Taxable – Build America Bonds) (the "Series 2009 Bonds") pursuant to a Third Supplemental Trust Agreement dated as of December 1, 2009 (the "Third Supplemental Trust Agreement"); and

WHEREAS, the Series 2003 Bonds, the Series 2004 Bonds and the Series 2009 Bonds are the only bonds outstanding secured by the Original Trust Agreement, as amended and supplemented; and

WHEREAS, the Series 2003 Bonds maturing on or after May 1, 2014 are subject to optional redemption by the University on or after May 1, 2013 at a redemption price equal to 100% of the principal amount of the Series 2003 Bonds redeemed, plus accrued interest to the redemption date; and

WHEREAS, this Board desires to advance refund all or a portion of the Series 2003 Bonds if that advance refunding achieves savings; and

WHEREAS, this Board finds and determines that it is necessary and in the best interest of the University to issue, as a fourth issue of General Receipts Bonds, in one or more series, to (i) pay costs of construction of a new classroom building, renovations of existing

classrooms, replacing the main water lines, renovating the Student Union, renovating the concert hall, improving and adding outdoor student recreation space, acquiring a new building or buildings for research and administrative uses, constructing a new academic or research building, expanding the Creative Arts Center, replacement of the Nutter Center scoreboard, constructing parking lots, and acquiring additional real estate, together with all necessary appurtenances thereto (collectively, the "Series 2011 Project"), (ii) advance refund all or a portion of the Series 2003 Bonds to achieve savings, and (iii) pay costs of the issuance of such Bonds;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Wright State University (the "University"), that:

Section 1. Definitions; Interpretations and References.

(a) Definitions. Capitalized words and terms used in this resolution and not defined in this resolution shall have the meanings given to them in the General Bond Resolution. In addition to words and terms defined in the General Bond Resolution, the following words and terms shall have the following meanings unless otherwise therein provided or unless the context or use clearly indicates another or different meaning or intent:

"Authorized Denominations" means, as to the Series 2011 Bonds, \$5,000 or any integral multiple thereof.

"Bond Purchase Agreement" means, as to the Series 2011 Bonds, the Bond Purchase Agreement between the University and the Original Purchaser authorized in Section 3.

"Bond Redemption and Purchase Account" means the Bond Redemption and Purchase Account held by the Trustee in accordance with the Trust Agreement and the Escrow Agreement.

"Continuing Disclosure Agreement" means the Continuing Disclosure Agreement authorized in Section 3(c).

"Costs of Facilities" means Costs of Facilities as defined in the Original Trust Agreement.

"Escrow Agreement" means the Escrow Agreement between the University and the Trustee authorized in Section 4.

"Final Terms Certificate" means, as to the Series 2011 Bonds, the certificate authorized in Section 3, setting forth and determining certain terms and other matters pertaining to the

Series 2011 Bonds and their issuance, sale and delivery, consistent with this Resolution.

"Fourth Supplemental Trust Agreement" means the Fourth Supplemental Trust Agreement between the University and the Trustee authorized in Section 8.

"Interest Payment Dates" means, as to the Series 2011 Bonds, May 1 and November 1 of each year commencing May 1, 2012.

"Obligations" means bonds or notes or other evidence of obligations issued pursuant to the Act.

"Original Purchaser" means, as to the Series 2011 Bonds, PNC Capital Markets LLC.

"Principal Payment Dates" means, as to the Series 2011 Bonds, May 1 in each of the years in which principal is payable.

"Project Fund" means the Series 2011 Project Fund created pursuant to the Fourth Supplemental Trust Agreement.

"Refunded Bonds" means those Series 2003 Bonds designated by the Fiscal Officer in the Final Terms Certificate to be advance refunded with proceeds of the Series 2011 Bonds.

"SEC Rule 15c2-12" means Rule 15c2-12 promulgated by the Securities and Exchange Commission pursuant to the Securities Exchange Act of 1934.

"Series 2011 Bonds" means the University's General Receipt Bonds, Series 2011 authorized in Section 2.

"Trust Agreement" means the Original Trust Agreement, as supplemented by the First Supplemental Trust Agreement, the Second Supplemental Trust Agreement, the Third Supplemental Trust Agreement and the Fourth Supplemental Trust Agreement.

"Trustee" means The Bank of New York Mellon Trust Company, N.A., as successor trustee in accordance with the Trust Agreement.

Section 2. Issuance of Series 2011 Bonds. This Board finds and determines that the facilities comprising the Series 2011 Project are Facilities and it is necessary and proper and in the best interest of the University to, and the University shall, issue General Receipts Bonds, in a maximum aggregate principal amount not to exceed \$63,000,000 for the purposes of paying Costs of Facilities of the 2011 Project, advance refunding the Refunded Bonds and paying costs of the issuance of the Series 2011 Bonds. Those Bonds shall be designated "General

Receipts Bonds, Series 2011" or as otherwise provided in the Final Terms Certificate. The Final Terms Certificate may specify that the Series 2011 Bonds may be issued in one or more separate series, each bearing a distinctive designation, provided that the Bonds of all series satisfy the requirements of this Resolution. The aggregate principal amount of Series 2011 Bonds to be issued, not exceeding the amount of \$63,000,000, shall be in an amount determined in the Final Terms Certificate to be the aggregate principal amount that is necessary, taking into account any discount from the aggregate principal amount of the Series 2011 Bonds at which they are sold to the Original Purchaser, in order to effect the purpose for which the Series 2011 Bonds are to be issued.

(a) General Terms and Provisions of the Series 2011 Bonds. The Series 2011 Bonds shall be issued only as Registered Bonds, substantially in the form or forms to be set forth in the Fourth Supplemental Trust Agreement. The Fiscal Officer is authorized and directed to sign and deliver, in the name and on behalf of the University, a letter agreement with any Securities Depository to record ownership and effect transfers of the Series 2011 Bonds in a book entry system. The terms, provisions, denominations and principal maturities of, redemption provisions applicable to, and the interest rates to be borne by, the Series 2011 Bonds shall be those as set forth in the Final Terms Certificate, which shall not be inconsistent with the provisions of this Resolution. The Series 2011 Bonds shall be dated as of the date of their initial delivery.

Series 2011 Bonds shall be numbered in such manner as determined by the Fiscal Officer in order to distinguish each Series 2011 Bond from any other Series 2011 Bond, may be subject to optional redemption in the amounts, upon the conditions, and at the times and prices, and may be subject to Mandatory Sinking Fund Redemption in the amounts and at the times and prices, all as provided for by or pursuant to this Resolution or Final Terms Certificate and in accordance with the Trust Agreement. Bond Service Charges on the Series 2011 Bonds shall be payable as provided in the Trust Agreement, without deduction for the services of any Paying Agent.

(b) Principal Maturities and Interest Rates. The Series 2011 Bonds shall mature on the Principal Payment Dates, and shall be payable in the principal amounts or in accordance with Mandatory Sinking Fund Requirements, as to be set forth in the Final Terms Certificate subject to the provisions of Section 3. The Series 2011 Bonds shall bear interest from their date or the most recent date to which interest has been paid or duly provided for at the rates per annum, payable on each Interest Payment Date, as to be set forth in the Final Terms Certificate subject to the provisions of Section 3.

(c) Mandatory and Optional Redemption. The Series 2011 Bonds may be subject to optional redemption prior to stated maturity, and may be subject to Mandatory Sinking Fund Redemption, as follows:

Mandatory Sinking Fund Redemption. If requested by the Original Purchaser and designated in the Final Terms Certificate, all or a portion of the Series 2011 Bonds may be issued as Term Bonds subject to Mandatory Redemption prior to stated maturity in part pursuant to Mandatory Sinking Fund Requirements, at a redemption price of 100% of the principal amount redeemed plus interest accrued to the redemption date. The Mandatory Sinking Fund Requirements of any Term Bond shall be set forth in the Final Terms Certificate.

The aggregate of the money to be deposited with the Trustee in the Bond Service Account for payment of Bond Service Charges on Term Bonds shall include amounts sufficient to redeem the principal amount of Term Bonds on the respective dates as stated in the principal maturity schedule set forth in the Final Terms Certificate (less the amount of any credit as provided below). If retired only by Mandatory Sinking Fund Redemption prior to their stated maturity, the remaining principal amount of any Term Bonds will be paid at their stated maturity date.

The University shall have the option to deliver to the Trustee for cancellation Term Bonds in any aggregate principal amount and to receive a credit against any then current Mandatory Sinking Fund Requirement (and corresponding Mandatory Redemption Obligation) for any Term Bonds. That option shall be exercised by the University on or before the 45th day preceding the applicable Mandatory Redemption date, by furnishing the Trustee a certificate signed by the Fiscal Officer setting forth the extent of the credit to be applied with respect to the then current Mandatory Sinking Fund Requirement. If a certificate is not timely furnished to the Trustee, the Mandatory Sinking Fund Requirement (and corresponding Mandatory Redemption Obligation) shall not be reduced. A credit against the then current Mandatory Sinking Fund Requirement (and corresponding Mandatory Redemption Obligation) also shall be received by the University for any Term Bonds which prior thereto have been redeemed (other than through the operation of Mandatory Sinking Fund Requirements) or purchased for cancellation and cancelled by the Trustee, to the extent not applied previously as a credit against any Mandatory Redemption Obligation. Each Term Bond so delivered, or previously redeemed, or purchased and cancelled, shall be credited by the Trustee at 100% of its principal amount against the then current Mandatory Sinking Fund Requirement (and corresponding Mandatory Redemption Obligation). Any excess of that amount over the then current Mandatory Sinking Fund Requirement shall be credited against subsequent Mandatory Sinking Fund Requirements (and corresponding Mandatory Redemption Obligations) in the order directed by the Fiscal Officer.

Optional Redemption. The Series 2011 Bonds maturing on or after a date stated in the Final Terms Certificate shall be subject to redemption by and at the option of the University in whole or in part on the dates provided in the Final Terms Certificate and in integral multiples of \$5,000 and at the redemption prices equal to the percentages of the principal amount redeemed as provided in the Final Terms Certificate plus in each case accrued interest to the redemption date.

If optional redemption of any Term Bonds at a redemption price exceeding 100% of the principal amount to be redeemed is to take place as of any applicable Mandatory Redemption date provided for pursuant to the above provisions, the Term Bonds or portions of Term Bonds to be redeemed shall be selected by lot prior to the selection by lot of the Term Bonds to be redeemed on the same date by operation of the Mandatory Redemption Obligations.

Series 2011 Bonds to be redeemed pursuant to optional redemption shall be redeemed only upon written notice from the University to the Trustee, given upon the direction of the Board by adoption of a resolution. That notice shall specify the redemption date and the principal amount of each maturity of Bonds to be redeemed, and shall be given at least 45 days prior to the redemption date or such shorter period as shall be acceptable to the Trustee. In the event that notice of redemption shall have been given by the Trustee to the registered owners as provided in the Trust Agreement there shall be deposited with the Trustee, on or prior to the redemption date, moneys that, in addition to any other money available therefore and held by the Trustee, will be sufficient to redeem at the redemption price thereof, plus interest accrued to the redemption date, all of the redeemable Bonds for which notice of redemption has been given.

Further procedures and conditions for the satisfaction of the Mandatory Sinking Fund Requirements and optional redemption are to be set forth in the Trust Agreement.

(e) Signing. The Series 2011 Bonds shall be signed by at least two of the following officers: the President, Fiscal Officer and Chair of the Board. Any or all of those signatures may be by facsimile.

(f) Authorization of Bond Rating and Credit Support Instrument. If in the judgment of the Fiscal Officer the filing of applications for a rating on the Series 2011 Bonds by one or more Rating Services, or for a Credit Support Instrument relating to the Series 2011 Bonds, are necessary or desirable for marketing purposes, the Fiscal Officer is authorized to prepare and submit either or both of those applications, to provide such information as may be required in support of them and to provide for the payment of the cost of such a rating or other Credit Support Instrument as financing costs payable by the University from proceeds of the Series 2011 Bonds to the extent available and then from other money lawfully available and appropriated or to be appropriated for that purpose. Any such action heretofore taken by the Fiscal Officer is hereby approved, ratified and confirmed.

(g) Book Entry Form. The Series 2011 Bonds shall be issued to a Securities Depository for use in a book entry system. If and as long as a book entry system is utilized, all of the following apply:

(i) The Series 2011 Bonds shall be issued in the form of a single Registered Bond representing each maturity and series and registered in the name of the Securities Depository or its nominee, as registered owner, and immobilized in the custody of the Securities Depository.

(ii) The owners of book entry interests shall have no right to receive Bonds in the form of physical securities or certificates.

(iii) Ownership of book entry interests in book entry form shall be shown by book entry on the system maintained and operated by the Securities Depository and its participants, and transfers of the ownership of book entry interests shall be made only by book entry by the Securities Depository and its participants.

(iv) The Bonds as such shall not be transferable or exchangeable, except for transfer to another Securities Depository or to another nominee of a Securities Depository, without further action by the University.

If any Securities Depository determines not to continue to act as a Securities Depository for the Series 2011 Bonds for use in a book entry system, the Fiscal Officer and Trustee may attempt to establish a securities depository/book entry relationship with another qualified Securities Depository. If the Fiscal Officer and Trustee do not or are unable to do so, the Fiscal Officer and Trustee, after making provision for notification of the owners of book entry interests in the Bonds by the then Securities Depository and any other arrangements deemed necessary, shall permit withdrawal of the Bonds from the Securities Depository, and authenticate and deliver Registered Bond certificates in Authorized Denominations to the assigns of the Securities Depository or its nominee, and if the event is not the result of University action or inaction, all at the cost and expense (including any costs of printing) of those persons requesting such issuance.

The Fiscal Officer and Trustee are authorized and directed to the extent necessary or required to enter into any agreements or make any representations determined necessary in connection with the book entry system for the Series 2011 Bonds, after determining (as evidenced by their signing) that their signing will not endanger the funds or securities of the University under the Trust Agreement.

Section 3. Sale of Series 2011 Bonds; Disclosure Documents; Continuing Disclosure Agreement.

(a) General. The Series 2011 Bonds are awarded and sold to the Original Purchaser in accordance with the Bond Purchase Agreement and at a purchase price (not less than 98% of the aggregate principal amount of the Series 2011 Bonds), as determined in the Final Terms Certificate.

For the purpose of implementing the provisions of this Resolution, the Fiscal Officer is authorized and directed to sign the Final Terms Certificate selling the Series 2011 Bonds to the Original Purchaser at the price established in the Final Terms Certificate and in accordance with this Resolution, and to evidence that sale and the further terms and provisions of that sale and of the Series 2011 Bonds by completing, signing and delivering the Final Terms Certificate, and a Bond Purchase Agreement substantially in the form now on file with the Secretary. The Final Terms Certificate and the Bond Purchase Agreement shall have provisions as are not inconsistent with this Resolution and not substantially adverse to the University and as shall be approved by the Fiscal Officer. The determination that those provisions are not substantially adverse to the University shall be conclusively evidenced by that officer's signing.

Having due regard to the best interests of the University and the anticipated General Receipts, there shall be further determined in the Final Terms Certificate or, as appropriate, in the Trust Agreement consistent with the provisions of this Resolution, (a) the final aggregate principal amount of the Series 2011 Bonds, (b) the aggregate principal amount, if any, of the Series 2011 Bonds to be issued as Serial Bonds or as Term Bonds, (c) the Principal Payment

Dates for those Series 2011 Bonds and the principal amount of those Series 2011 Bonds that shall be stated to mature on each such Principal Payment Date, and as to any Term Bonds the Principal Payment Dates on which Term Bonds shall be subject to Mandatory Sinking Fund Redemption and the principal amount that shall be payable pursuant to Mandatory Sinking Fund Requirements on each Mandatory Redemption Date in accordance with the provisions of the Trust Agreement, (d) any optional redemption provisions, and (e) the rate or rates of interest to be borne by the Series 2011 Bonds, all subject, however, to the following further considerations and limitations:

(i) The rate or rates of interest per year to be borne by the Series 2011 Bonds shall be such as are determined to be required by marketing considerations and to result in the sale of the Series 2011 Bonds on a basis most favorable to the University. The weighted average interest rate of the Series 2011 Bonds shall not exceed 6% per annum.

ii) The schedule of the principal amount of Series 2011 Bonds maturing or payable pursuant to Mandatory Sinking Fund Redemption requirements on each Principal Payment Date shall be determined to be consistent with the anticipated General Receipts. The first principal payment shall be not later than May 1, 2013 and the final principal payment shall be not later than May 1, 2036. The schedule of the maturing principal amounts of the Series 2011 Bonds shall be such that the weighted average maturity of the Series 2011 Bonds shall not exceed 18 years.

It is hereby determined by this Board that the terms of the Series 2011 Bonds, the procedures for their sale, and the determination of the price to be paid for them, all as established in accordance with this Resolution, the Bond Purchase Agreement and the Fourth Supplemental Trust Agreement, are and will be in the best interest of the University and in compliance with all legal requirements.

The President, the Fiscal Officer, the Chair of the Board and the Secretary are directed to make the necessary arrangements on behalf of the University to establish the date, location, procedure and conditions for the delivery of the Series 2011 Bonds to the Original Purchaser and to take all actions necessary to effect due signing, authentication and delivery of the Series 2011 Bonds under the terms of this Resolution, the Bond Purchase Agreement and the Trust Agreement.

(b) Disclosure Documents. The President and the Fiscal Officer, each are authorized and directed, on behalf of the University and in their official capacities, to:

(i) Prepare or cause to be prepared, and make or authorize modifications, completions or changes of or supplements to, a disclosure document in the form of a

(ii) preliminary official statement relating to the issuance of the Series 2011 Bonds and determine, and certify or otherwise represent, when the preliminary official statement as so prepared is a "deemed final" official statement (except for permitted omissions) by the University as of its date for purposes of SEC Rule 15c2-12(b)(1). The distribution and use of such a preliminary official statement is hereby authorized and approved.

(iii) Complete that preliminary official statement with such modifications, changes and supplements as those officers shall approve or authorize for the purpose of preparing and determining, and to certify or otherwise represent, that the official statement as so revised is a final official statement for purposes of SEC Rule 15c2-12(b) (3) and (4). Those officers each are further authorized to use and distribute, or authorize the use and distribution of, the final official statement and supplements thereto in connection with the original issuance of the Series 2011 Bonds as may, in their judgment, be necessary or appropriate.

Those officers and each of them are also authorized to sign and deliver, on behalf of the University and in their official capacities, the final official statement and such certificates in connection with the accuracy of the preliminary official statement and the final official statement and any amendment thereto as may, in their judgment, also be necessary or appropriate.

(c) Continuing Disclosure Agreement. For purposes of SEC Rule 15c2-12 the University, for the benefit of the holders and beneficial owners of the Series 2011 Bonds, makes a continuing disclosure agreement to be further detailed in the Continuing Disclosure

Agreement. The Fiscal Officer shall have the responsibility for the compliance by the University with that Continuing Disclosure Agreement, and that officer shall establish procedures in order to ensure that compliance, including signing the Continuing Disclosure Agreement substantially in the form now on file with the Secretary. The Continuing Disclosure Agreement shall have provisions not inconsistent with this Resolution, not materially adverse to the University, as necessary for compliance with SEC Rule 15c2-12 and approved by the Fiscal Officer. The determination that such provisions are not materially adverse to the University shall be conclusively evidenced by the signing of the Continuing Disclosure Agreement by the Fiscal Officer. That Continuing Disclosure Agreement shall be the continuing disclosure agreement for purposes of SEC Rule 15c2-12.

Section 4. Advance Refunding of Refunded Bonds. The Fiscal Officer is authorized and directed to determine those Series 2003 Bonds, if any, to be Refunded Bonds in order to achieve savings for the University. The Fiscal Officer shall designate the Refunded Bonds in the Final Terms Certificate. If the Fiscal Officer determines that there shall be Refunded Bonds, the Fiscal Officer shall cause the advance refunding of the Refunded Bonds, including providing for the redemption of the Refunded Bonds on May 1, 2013, providing for the notices of such advance refunding and redemption required by the Trust Agreement, in such a manner that the Refunded Bonds shall be deemed discharged and defeased in accordance with Article IX of the Original Trust Agreement. The President and the Fiscal Officer are authorized, for and in the name of the University and on its behalf, to sign and deliver the Escrow Agreement substantially in the form now on file with the Secretary. The Escrow Agreement shall have provisions not inconsistent with this Resolution, not materially adverse to the University, permitted by the Act and as approved by the officers signing it. The determination that such provisions are not materially adverse to the University shall be conclusively evidenced by the signing of the Escrow Agreement by those officers.

Section 5. Application of Proceeds of Series 2011 Bonds. The proceeds from the sale of the Series 2011 Bonds shall be allocated and deposited in the following order:

(a) To the Trustee, an amount, if any, to be deposited into the Bond Redemption and Purchase Agreement in accordance with the Escrow Agreement, sufficient to discharge and defease the Refunded Bonds, and

(b) To the University, the remaining amount to be deposited into the Project Fund to be used to pay Costs of Facilities of the Series 2011 Project.

The proceeds of the sale of the Series 2011 Bonds are appropriated and shall be used for the above purposes.

Section 6. Covenants of the University. The University, by issuance of the Series 2011 Bonds, covenants and agrees with their holders to perform its applicable covenants and agreements set forth in the General Bond Resolution, this Resolution and in the Trust Agreement. Each of those obligations is binding upon the University, and upon each University officer or employee as from time to time may have the authority under law to take any action on behalf of the University that may be necessary to perform all or any part of that obligation, as a duty of the University and of each of those officers and employees resulting from an office, trust or station within the meaning of Section 2731.01 of the Revised Code, providing for enforcement by writ of mandamus.

Section 7. Tax Covenants. The University covenants that the University will restrict the use and investment of the proceeds of the Series 2011 Bonds in such manner and to such extent, if any, as may be necessary after taking in the reasonable expectations at the time the

Series 2011 Bonds are issued, so that the Series 2011 Bonds will not (i) constitute private activity bonds, arbitrage bonds or hedge bonds under Section 141, 148 or 149 of the Code, or (ii) be treated other than as bonds to which Section 103(a) of the Code applies, and (b) the interest thereon will not be treated as an item of tax preference under Section 57 of the Code.

The University represents that it has not formed or participated in the formation of, or benefited from or availed itself of, any entity in order to avoid the purposes of subparagraph (C) or (D) of Section 265(b)(3) of the Code, and covenants that it will not form, participate in the formation of, or benefit from or avail itself of any such entity. The University further represents that the Series 2011 Bonds are not being issued as part of a direct or indirect composition issue that combines issues or lots of tax-exempt obligations of different issuers.

The University further covenants that (a) it will take or cause to be taken such actions that may be required of it for the interest on the Series 2011 Bonds to be and to remain excluded from gross income for federal income tax purposes, (b) it will not take or authorize to be taken any actions that would adversely affect that exclusion, and (c) it, or persons acting for it, will, among other acts of compliance, (i) apply the proceeds of the Series 2011 Bonds to the governmental purposes of the borrowing, (ii) restrict the yield on investment property, (iii) make timely and adequate payments to the federal government, (iv) maintain books and records and make calculations and reports, and (v) refrain from certain uses of the proceeds of the Series 2011 Bonds and, as applicable, of property financed with such proceeds, all in such manner and to the extent necessary to assure such exclusion of that interest under the Code.

The Fiscal Officer, or any other officer of the University having responsibility for issuance of

the Series 2011 Bonds is hereby authorized (a) to make or effect any election, selection, designation, choice, consent, approval, or waiver on behalf of the University with respect to the

Series 2011 Bonds as the University is permitted or required to make or give under the federal income tax laws, including, without limitation thereto, any of the elections provided for in Section 148(f)(4)(C) of the Code or available under Section 148 of the Code, for the purpose of assuring, enhancing or protecting favorable tax treatment or status of the Series 2011 Bonds or interest thereon or assisting compliance with requirements for that purpose, reducing the burden or expense of such compliance, reducing the rebate amount or payments or penalties, or making payments of special amounts in lieu of making computations to determine, or paying, excess earnings as rebate, or obviating those amounts or payments, as determined by that officer, which action shall be in writing and signed by the officer, (b) to take any and all other actions, make or obtain calculations, make payments, and make or give reports, covenants and certifications of and on behalf of the University, as may be appropriate to assure the exclusion of interest from gross income and the intended tax status of the Series 2011 Bonds, and (c) to give one or more appropriate certificates of the University, for inclusion in the transcript of proceedings for the Series 2011 Bonds, setting forth the reasonable expectations of the University regarding the amount and use of all the proceeds of the Series 2011 Bonds, the facts, circumstances and estimates on which they are based, and other facts and circumstances relevant to the tax treatment of the interest on and the tax status of the Series 2011 Bonds.

Section 8. Fourth Supplemental Trust Agreement. To secure the payment of the Bond Service Charges as the same shall become due and payable and the performance by the University of its obligations provided for in the Bond Proceedings and the Series 2011 Bonds, the President and the Fiscal Officer are authorized, for and in the name of the University and on its behalf, to sign and deliver to the Trustee the Fourth Supplemental Trust Agreement substantially in the form now on file with the Secretary. The Fourth Supplemental Trust Agreement shall have provisions not inconsistent with this Resolution, not materially adverse to the University, permitted by the Act and as approved by the officers signing it. The determination that such provisions are not materially adverse to the University shall be conclusively evidenced by the signing of the Fourth Supplemental Trust Agreement by those officers.

Section 9. Other Documents. The President, the Fiscal Officer, and the Chair and Vice-Chair of the Board are authorized and directed to furnish, sign and deliver such other documents, certificates and instruments as may be necessary or appropriate to issue the Series 2011 Bonds and to consummate the transactions contemplated in this Resolution, the Fourth Supplemental Trust Agreement, the Escrow Agreement and the Bond Purchase Agreement. The Secretary to the Board or other appropriate officials of the University shall furnish the Original Purchaser a true transcript of proceedings certified by such officers of the University as may be appropriate of all proceedings had with reference to the issuance of the Series 2011 Bonds.

Section 10. Interpretations and References. Any reference in the Bond Proceedings to the University, or to its Board or College, or its or their officers, or to other public bodies, boards, commissions, departments, institutions, agencies, bodies, entities or officers, shall include those that succeed to their functions, duties or responsibilities pursuant to or by operation of law or otherwise are lawfully performing their functions.

Any reference in the Bond Proceedings to a section or provision of the Revised Code or to the Act or to the laws of Ohio or Board resolutions shall include that section or provision and the Act and those laws and resolutions as from time to time amended, modified, revised, supplemented or superseded. No amendment, modification, revision, supplement or superseding section or provision shall be applicable solely by reason of this provision, if it constitutes in any way an impairment of the rights or obligations of the University, the holders, the Trustee, any Credit Support Provider, or the Registrar, under the Bond Proceedings or any other instrument or document entered into in connection with any of the foregoing, including without limitation, any alteration of the obligation to pay Bond Service Charges in the amount and manner, at the times and from the sources provided in the Bond Proceedings and the Bonds, except as permitted in the Trust Agreement.

Section 11. Compliance with Open Meeting Law. This Board finds and determines that all formal actions of this Board and any of its committees concerning and relating to the adoption of this Resolution, and that all deliberations of this Board and of any committee that resulted in those formal actions, were in meetings open to the public in compliance with the law including Section 121.22 of the Revised Code.

RESOLVED that the Bond/Sale resolution as submitted to this meeting be, and the same hereby is approved.

### **C. Advancement Committee Report**

#### **1. Alumni Relations Report September 2011**

##### **Recent Alumni Events**

- As of September 6, 2011, the Alumni Scholarship Appeal has raised nearly 50% of its overall goal of to benefit the African American Alumni Society Scholarship (\$10,000 goal), Social Work Society Scholarship (\$10,000 goal), and the WSUAA Legacy Scholarship (\$40,000 goal).
- WSU Alumni Day at King's Island was held on July 9, 2011, with 221 in attendance.
- WSUAA Legacy Scholarship Golf Outing was held at the Dayton Country Club on August 15, 2011. 148 golfers participated this year and it is projected that \$12,000 was raised from the event for the legacy scholarship fund.

- We have been working with alumni in Indianapolis, Atlanta, New York City (tri-state area) and Tampa to develop alumni networks in these areas.
- On July 21, 2011, Tampa alumni gathered for an event at a Tampa Bay Rays baseball game. It was a sold out event with 51 individuals in attendance. The goal was to create enthusiasm for a developing network in Tampa. They plan to have an event in November 2011 with the WSU Raiders men's basketball team playing the University of Florida in Tampa.

### **Summer Network/Society Activity**

**Cleveland-**The Cleveland Alumni Network held an event on July 31, 2011, at the Cleveland Indians baseball game with a tailgate prior to the game. This was the first family friendly formatted event in the Cleveland area; the network had over 80 attendees.

**Dayton-** Social event at the Frazee: The Menu on August 12, 2011. There were 42 in attendance.

The Dayton network participated in both the Fairborn Fourth of July parade and Vectren Air Show parade. The Wright State University Alumni Association won the Judges Award at the Fairborn parade for its WSUAA float.

Dayton network held a membership drive meeting on campus on August 9, 2011. There were 18 in attendance.

**Lake Campus Network-** The network was involved in several new student orientations. Members hung banners in communities surrounding Lake Campus to welcome students to the WSULC.

**Cincinnati Network** – The Cincinnati Network held a quarterly social happy hour event at Chi NATTI's on June 14, 2011. There were 10 attendees.

## **2. Wright State University Foundation Report September 16, 2011**

Fiscal year 2012 started off with a slight loss for the month of July 2011. The return was a negative 0.8% for the month versus a benchmark of - 0.2%. The value of the endowment portfolio at July 31, 2011, was \$69.9 million, with asset allocations within policy tolerances. Although the numbers are not yet available, our portfolios no doubt experienced a greater loss in August as increased market volatility punished investors.

These recent trends somewhat offset a very positive FY11. For the year ended June 30, 2011, the endowment portfolio earned a 20.2% positive return, the second straight year of positive double digit returns and also the highest rate of return in at least the last ten years. Although this return equaled the portfolio's composite benchmark, it was 60 basis points better than a traditional 60/40 portfolio would have performed for the same period. The portfolio's 1-, 2-, 3-, 5-year and inception-to-date returns all show a positive return, with each period's return at least as strong as its related benchmark. This is an amazing turnaround given where the markets were just two years ago.

Investment earnings during FY11 were primarily responsible for the

Foundation's total assets surpassing the \$100 million level. Unrestricted

net assets also reached a new high of greater than \$5 million. This reserve provides a cushion greatly in excess of that required by the Foundation's reserve policy and allows the Foundation to respond positively to changing needs at Wright State. Although not completely eliminated, only 11 (of 345) of the Foundation's endowment funds remained underwater at the end of FY11.


Prior to the end of the fiscal year, the Foundation paid off the \$1.5 million loan undertaken more than ten years ago to partially finance the University's baseball stadium renovation project.



\* To July 31, 2011


## Endowment Historical Rates of Return

### **3. Development Report September 16, 2011**

#### **1) FY11 Close**

The year-end total for FY11 was \$20,204,521. This compares to a FY10 close of \$12,735,890. The most recent fiscal year closing represented a 57.9% increase in gifts received over the prior year.

There were significant non-cash gifts included in this gift total. They are as follows:

- Schlumberger software gift of \$5,000,000+ for the College of Science and Mathematics
- Dayton Daily News Archives collection appraised at \$2,500,000
- Planned gifts totaling \$6,445,715 as compared to \$1,125,000 in FY10

#### **2) July 2011 Gift Total**

Gifts received for the first month of FY12 were \$839,950. This compares to a prior year giving total of \$1,236,550 or a decline of 32%.

#### **3) Comprehensive Campaign Updates**

- Campaign gifts received to date: \$45 million+
- We are analyzing the gifts that have been received to understand how much progress has been made toward our campaign goals; scholarships, centers of excellence, and capital renovation and construction.
- President and Mrs. Hopkins are currently recruiting couples to serve on the campaign cabinet.
- Our campaign prospectus materials are being drafted for the Creative Arts Center, the campaign in general, and for scholarships.
- Foundation Board members are hosting receptions in their homes for President and Mrs. Hopkins to expand our circle of friends. Howard and Sally Stevens are hosting a reception for Dr. and Mrs. Hopkins on Monday, September 12<sup>th</sup>. The

guest list includes CEO's and spouses from Research Park.

- The Foundation Board of Trustees will have a campaign retreat on Thursday, September 29<sup>th</sup> led by Jennifer McDonough, campaign consultant.
- The Foundation Board is welcoming 5 new trustees with a series of orientation events, and a late afternoon social following the campaign retreat.
- The Major Gifts team is working individually with each of the deans to address their fundraising needs in the campaign, to strategize their goals, to assess the strength of their prospect base, and to build depth into their individual advisory boards.

#### **4) Planned Giving**

##### **FY11 Results**

- 21 planned gifts were recorded with a known value of \$6,470,715. One was a charitable gift annuity; the remainder were bequest intentions.

##### **As of 9/1/2011**

- 14 planned gifts are in discussion with a known or estimated value of \$5.7 million.
- 16 additional possible planned gifts are in the early stages of discussion (values yet to be determined)

#### **5) Annual Giving**

The Office of Annual Giving raises funds for the scholarships and programs that support Wright State students through annual initiatives such as direct mail, eSolicitations, phonathon, student giving, and the Campus Scholarship & Innovation Campaign (CSIC). Highlighted below are recent results from direct mail and CSIC.

##### **Direct Mail**

- Raised \$179,158 through direct mail/eSolicitation initiatives in FY11 (119% increase over FY10 - \$81,706)

## **Campus Scholarship & Innovation Campaign (CSIC)**

### *Wright State's Faculty, Staff, and Retiree Campaign*

- Surpassed the \$290,000 goal and raised \$360,366 from faculty, staff, and retirees during the 2011 CSIC. (Does not include annual gift from Wright State Physicians. Dollars are likely to increase significantly.)
- Surpassed the 45% participation goal as 46% of faculty and staff (35% including retirees) contributed during CSIC. (Does not include annual gift from Wright State Physicians. Participation is likely to increase. )
- Increased total personal Leadership Giving visits made by inviting Major Gift Officers to visit Leadership Giving prospects from their colleges.

#### **4. Communications & Marketing Report September 16, 2011**

The 4-person team constructing the first Content Management System (CMS) for Wright.edu has made significant progress. A "soft launch" for a number of sections within the new university website was completed on September 6. Thus, wright.edu went live with such web pages as the new quarters to semesters site (known as the "TAP" site), the home page and many other top level, or "student vital pages" (e.g. Campus Life). As well, an improved calendar system, emergency management, communications and marketing, the independent scholars network and student social media sections were introduced, among others.

A soft launch is one that is not publically announced. Doing so enables workers on the site both in Communications and Marketing and CaTS to fine tune without interruption, an important advantage with an enterprise site the size of wright.edu. Vital testing takes place in predawn hours every Tuesday. A load test on September 6 saw the new CMS build handle 24 million hits *a minute*. Heretofore, wright.edu has managed to handle just 6 million hits *per year*. The 24 million number is comparable in terms of site managing to a website the size of CNN. Hopefully, further testing will allow the university continued outstanding results.

While the CMS build and testing continues, work now is underway to redesign sections of the site, beginning with the Enrollment Management pages such as admissions, undergraduate, and graduate sections. To see the improved site, go to [www2.wright.edu](http://www2.wright.edu).

The fall issue of the *Wright State University Magazine* (formerly *Community Magazine*) was delivered on the day fall classes resumed, and publication of the fall version of the faculty-staff newsletter, *Dialogue*, also delivered that week. Both have been well received.

In the ongoing effort to gain higher recognition for Wright State, a video featuring service learning is in production, while WSU was nationally ranked No. 8 among "most giving schools in the U.S. in terms of community service" was achieved. The community service recognition came from the *Washington Monthly* and *The Huffington Post* and Communications and Marketing is leveraging this coverage into more recognition.

In the month of August alone, Communications and Marketing addressed 403 projects on its weekly assignments list on behalf of the various units on campus and on behalf of the university in general. The assignments included publicity efforts, printed publications and web work on deadline.

**C. Building & Grounds Report  
September 16, 2011**

**Project updates**

1. Temporary Classrooms – completed on-time and under budget.
2. Rinzler Student Sports Complex – several weeks behind schedule. A 72-hour notice has been sent and adjustments to the work schedule are being developed.
3. Schuster Concert Hall Renovation – also 3 weeks behind schedule; however, phase 1 contractor has been replaced and phase 2 is beginning on time. By staging the work, it is expected that the new contractor will have us caught up by 3<sup>rd</sup> week of October.
4. SAIC/University Park – analysis has been completed, decision as to which property we will acquire will be made by the end of September.
5. New Classroom Building, CAC Renovation and Neuroscience Building – we will progress with due haste once new architect/planners are in place. Interviews have been conducted, background checks have been made and we hope to make an offer this week.

**D. Enrollment Management Report  
September 16, 2011**

1. Fall Enrollment (14<sup>th</sup> Day)

- Fall 2011 enrollment is the second highest in the history of Wright State.
- 19,600 Total University Enrollment (unduplicated); 18,304 Main Campus; 1,417 Lake Campus
- 15,657 Undergraduate students; 3,943 Graduate/Professional students
- 10,774 Women (55%); 8,826 Men (45%)

2. Financial Aid

a. Applications (FAFSA) for 2010-2011 increased 10.01% over the 2009-2010 academic year. This increase is part of an ongoing trend of increasing applications since the 2007-2008 academic year. In addition, there was a 6.54% increase in the number of students who received aid during 2010-2011 over the 2009-2010 academic year. This trend is anticipated to continue through the 2011-2012 academic year. Most financial aid programs experienced an increase in number of awards and total amount awarded for the 2010-2011 academic year. Overall, there was a 7.60% increase in all aid programs over the 2009-2010 academic year. This increase does not signify an increase in the amount of funding, only an increase in the number of students who require financial aid.

b. A new Satisfactory Academic Progress policy has been federally mandated to begin for the 2011-2012 academic year. Although this is not a change in the current evaluation standards or method for which students are evaluated, an update in the way student appeals are evaluated has been instituted. This new process will take place at the end of fall quarter.

3. Vice President's Report

a. In August, the Enrollment Management Division hosted Dr. David Kalsbeek, a nationally recognized leader in Enrollment Management, who presented a daylong workshop for the Cabinet, Council of Deans, college enrollment representatives, and several faculty and senior staff. The sessions provided a perspective on a more market responsive approach to enrollment management as well as selected topics such as financial aid leveraging that will inform our next strategic plan.

b. As customer service is always in the forefront of supporting our students, the Division has continued to plan for the Wright State "one stop" student service center. To better understand students' needs and expectations within a student service center, we have begun the evaluation of successful regional "one stop" centers, while conducting student, faculty, and staff focus groups and surveys.

## **IX. REPORT OF THE PRESIDENT**

### **A. University Update**

President David R. Hopkins updated the Board on the following university activities:

1. Dr. Hopkins announced that one of the new housing buildings at Lake Campus was named Knapke Villa in honor of Dr. Tom Knapke.
2. He congratulated the faculty, the staff and students on the execution of the new mechanical engineering program. There is some discussion with local industry and businesses on how to make it a better fit you're the needs at the Lake Campus. The criminal justice program is up and running, with the academy continuing to serve a lot of people.
3. Congratulations on the March Regional Summit at the Lake. It was a wonderful event and with our concerted effort and all of us working together, we will bring the ideas that came from the summit to life here at the Lake Campus and this community.
4. Dr. Hopkins thanked Dr. Matt Filipic for his years of service as the Senior Vice President of Business and Fiscal Affairs.
4. Dr. Mark Polatajko was named the new Vice President of Business and Fiscal Affairs, replacing the retiring Dr. Filipic effective January 1, 2012.
5. The Dayton Regional Stem School officially opened at their permanent site on Woodman Drive in Kettering. It houses 350 students with more than 27 school districts represented with a very different and diverse group of students.
6. Last week was the celebration of our 100<sup>th</sup> graduate in our Ph.D. program in Engineering. Of the 100 students that graduated, half of those students are now working at the Air Force Research Lab at Wright Patterson Air Force Base and are doing very significant things for the future of our country.
7. On October 20<sup>th</sup>, the state of Ohio will announce that Wright State's 7<sup>th</sup> Center of Excellence will be an Ohio Center of Excellence in the Arts. As many of you know, WSU has very strong programs in theater, motion

pictures, dance, music and art.

8. Dr. Hopkins noted that everyone is working very hard on the water quality institute. There are multiple businesses and industries helping to be part of the solution, for not only the restoration of the Lake, but for how it could impact the economy. He stated that Wright State is committed to bring all of our capabilities to this issue and is committed to work with these partners to create this water quality institute that will allow us to do the kind of research and the monitoring as we go into the future.

#### **B. Report of Investments**

Since the last Board meeting, investments for April, May, June and July 2011 have been received. These reports have been distributed to the trustees and will be filed with the official Board of Trustees' records.

### **X. REPORTS OF THE COMMITTEES OF THE BOARD**

#### **A. Academic Affairs Committee**

##### **Provost Steven Angle's Report:**

Dr. Angle reported on enrollment for Fall 2011: Undergraduate enrollment is up 0.6% with graduate students down a small number. Enrollment is basically flat with last year's number.

Union negotiations are still on going. As the contract stands now, there would be no increase in salary for faculty, a 1% increase in the second year (academic year 2012-13) and 1% the following year.

Dr. Andrew Hsu, dean of the Wright State University Graduate School gave the committee an overview on what is occurring at the WSU Graduate School, including its strengths, challenges, opportunities and accomplishments achieved in 2010-11 and future directions for the school.

Dr. Thomas Sudkamp, associate provost for Undergraduate Studies and University College presented a power point presentation on student success and the University College. The University College mission statement states that it will provide access, guidance, and academic support to first-year, transfer, and adult students in a nurturing, diverse, respectful, and supportive environment that assists students in making a successful transition to college and appropriate majors, while developing the foundations for civic engagement and lifelong

learning.

**B. Finance and Audit Committee**

Mr. Dennis Obyc from Crowe Horwath LLP reviewed the bulleted handout and discussed the process of the audit with the committee. Mr. Obyc also discussed a proposed new accounting standard that, if implemented, would require the

University to book as a liability a pro rata share of the unfunded liability of the state retirement systems. Because of the amounts involved, the change would obscure our actual results and financial position, making our financial statements much less useful to the Board or to other users of the statements.

Mr. Keith Ralston reviewed the university's expenditures of \$250,000-\$499,999. No action was required.

Mr. Jeff Ulliman shared the university's investment reports for April, May, June, July 2011 and the August 2011 summary.

**Senior Vice President Filipic's Report**

Dr. Matt Filipic, senior vice president for Business & Fiscal Affairs, reported that the revenue news is mixed at best. As of the end of the first week of classes, fall enrollments and tuition charges are below the levels assumed in the budget. Turmoil in the financial markets has generated investment losses. Fortunately, state revenues are tracking estimates, so there is no immediate prospect of state budget reductions.

He has just received responses to our Invitation to Negotiate electricity prices. Our current agreement with DP&L extends through 2012, but we believe we will be able to negotiate very substantial savings beginning in 2013.

We are completing work on the purchase of the property from the archdiocese. We are also making progress in developing a wellness program.

University Business Officers met with the state budget director last week. We learned that there would be no capital bill in 2011 and that there are constraints on the size of a possible capital bill in 2012.

We are continuing to work with the IUC on the Chancellor's proposal to create Enterprise Universities. We continue to fear that the value of any deregulation that might be accomplished is substantially less than the amount of state subsidy

reduction that would be demanded.

The Auditor of State has announced a new procedure for the selection of external auditors by campuses that seem to reduce our ability to influence the selection. Our current auditor is completing their five year cycle, so we will be going through the selection process this fall.

**C. Student Affairs Committee**

**Vice President's Report**

Dr. Dan Abrahamowicz, vice president for Student Affairs, noted that a purchase agreement has been signed by Wright State and the Archdiocese of Cincinnati to enable the university to acquire 4 acres of land in the center of campus. The diocese will develop a spiritual center adjacent to this land and the university will work to develop a commons building on the 4 acres.

The Cimmeron Woods apartment complex is for sale and is being evaluated as a partial solution for replacement housing when the Forest Lane housing buildings are retired.

A ribbon cutting ceremony is being held for the Rinzler Student Athletic Complex. Construction is nearing completion and a formal dedication will be held at a later time. This weekend the United States Air Force is holding their annual 5K Race and Marathon at Wright State along with the assistance of Campus Recreation and other university staff and students.

Upcoming is Career Service's "Recruiting Day" for students interested in internships, co-ops, and full time positions. Over 650 students are registered to attend this two day event targeting public service, STEM, business and creative careers. The three finalists for the position of vice president for Business and Fiscal affairs will also be interviewing on campus next week.

**Student Government Report**

Mr. Paul Reid, Student Government president, outlined the activities Student Government has participated in over the last few weeks. "Move In", "First Weekend", "Do the U", "Boogie on the Bricks" and "Fall Fest" were all very well attended student events. The incoming Freshmen Class is exhibiting a higher level of excitement and engagement than seen in previous years and Student Government is working hard to help all students feel connected to Wright State

and to build upon this enthusiasm.

Mr. Nick Warrington, Student Government vice president, discussed some of the joint ventures Student Government is participating in with the Dayton Chamber of Commerce and with University Directories. The Chamber provided 5,000 Speedway gas discount gift cards and University Directories produced 5,000 free daily planners to be given away to students.

### **Updates**

Mr. Dan Bertsos, director of Residence Services, offered a Residential Services' update on Move-In Day, Lake Campus construction projects, improvements to housing, new Learning Communities and new methods being used to share information with students.

Over 530 volunteers upheld the long standing tradition of an efficient move-in day process. In fact, the incoming freshmen class completed move-in by noon; the earliest completion ever.

From its early spring groundbreaking, the Lake Campus housing project is nearing completion. Community directors have been hired and occupancy will be ready in late October.

All remodeling projects in the Woods Residential Complex have been completed, the Honor's Fitness Center has been expanded, a new classroom was created in the basement of Hamilton Hall and security cameras have been placed in the residence community. Additional Learning Communities have been established for students interested in Sports Medicine, for students leaving foster care, and for Mixed Gender Housing apartments.

Ms. Simone Polk, assistant vice president, spoke of the challenges facing students who are emancipating from the foster care system. When a student turns 18 years of age by law he/she is effectively prevented from contacting their foster family, school district and caseworker support system. Left without guidance and a home, these students find it difficult to navigate college and the requirements for successful degree completion.

Wright State has created an "Independent Scholars Network" to establish a safety net to assist these students in identifying the necessary resources to allow them to establish housing, gain employment and meet the challenges in obtaining a college degree. Included in the series are peer mentors, academic counseling,

time management training, personal budgeting, resume development and career coaching.

The program has become a statewide model in improving the chances of success for these students.

**D. Faculty President's Report**

Dr. Krane reported that the Faculty Senate is proceeding on pace with the quarter to semester transition. In fact, just this past week the Senate had a meeting in which they made some adjustments to the starting times of our classes.

The Faculty Senate is very interested in the construction of the new classroom building that's related to one of the bonds that was mentioned. The Building and Grounds Committee of the Faculty Senate is very actively engaged in having faculty input not just in the design of the building but also to its placement on campus.

Of late, the Faculty Senate Budget Priority Committee is becoming very engaged in a review of the university's new budgeting model of responsibilities centered management approach. We're endeavoring to make sure that this budget model is reflective and captures the essence of the university's mission, placing a priority and value on scholarships and the assistance we give to our students.

Lastly, I think something that's going to be an emerging issue with the Senate over the next several month is how we're serving those students at Wright State who are least well prepared to attend a 4-year university. There will be some serious discussions about what we can do to better serve those individuals.


