Buildings & Grounds Committee – Linda Ramey

University Building and Grounds Committee met on Monday September 24th, 2012

- Neuroscience and Engineering Collaborative Building (NEC) is in the design phase. The NEC will not pursue LEED certification.
- The New Classroom Building (NCB) is in the initial stages of preliminary program review to establish the size, shape and room requirements. Discussion continues related to benefits vs. costs of LEED certification.
- New Student Commons Building, no report
- Wright Way Policy continues to be in process according to Dr. Polatajko.
- Raider Connect will open Oct 1, 2012 temporarily in the Pathfinder Lounge until July, 2013. Back office personnel will permanently move to 2nd floor of Medical Sciences when renovations are completed.
- Establishing a more formal, campus-wide initiative needed for expansion of Green Office Initiatives.
- Recycling containers – Now have 50 on campus with very positive feedback. Student Government questions the present outlying placements on campus. Also requested more bike racks near campus buildings.
- WSU Tobacco-Free campus (promoted summer 2012, Ohio Board of Regents). SG passed resolution for smoking ban within 50 feet of buildings, recommended ‘smoking zones’.
- Campus Signage Improvements, Dr. Sweeney states information coming soon.
- Physical Plant concerns, Dan Papay, Jeff Trick:
- Removal of deteriorated artwork on campus – “Horizons” and “Divisions”
- Ongoing expense of maintaining Allyn Hall moat discussed.
- Univ. Building and Grounds committee will meet October 29, 2012.

Information Technology Committee – John Gallagher

The IT committee met on Wednesday, Oct 10 at 2:00 PM.

- Dr. Travis Doom, chair of the Ad Hoc Committee on IT Integration and Effectiveness, gave a short report on that committee’s charge, function, and intended goals. He also reported that J. Gallagher and S. Schiller were members of that ad hoc committee and invited other members of the standing IT committee to send comments and suggestions through Drs. Gallagher and Schiller.
- Dr. Sarah Twill (CTL) reports that Pilot will be patched to version 10. This update, which will most likely be applied between the fall 2012 and spring 2013 semester, will provide an improved user interface, analytics as requested by several units, and the ability for faculty and staff to send email to addresses outside the pilot system.
- The committee discussed recent faculty complaints of slow boot times for computers at instructional stations in classrooms. CaTS reports that they conducted a study of the problem and deployed those fixes that were possible without disrupting services in the middle of a semester. CaTS reports that boot times on most instructional machines is now down to 1 to 2 minutes.
- CaTS action items will be considered in the next meeting to be held in November.

WRIGHT STATE UNIVERSITY Graduate Council Report to the Faculty Senate October 2012

The Wright State University Graduate Council met on October 4, 2012. Its standing committees met prior to that date.

I. REPORT OF THE DEAN

RACGS – The schedule of meetings for the Regents' Advisory Committee on Graduate Study (RACGS) recently changed to an every-other-month schedule. Please be aware of the timing of the meetings for future program approvals.

Doctoral Program Reviews – Wright State receives special doctoral program support from the state of Ohio. In exchange, the state has mandated program reviews. Last academic year, three of the research-based doctoral programs conducted an internal self-study and underwent an external review: PhD in Engineering, Computer Science and Engineering PhD, and Biomedical Sciences PhD. The final reports from these reviews have been shared with the program directors and college deans and response documents/action plans are being developed. The Environmental Sciences PhD and Human Factors, Industrial, Organizational Psychology PhD programs will be reviewed this academic year.

II. REPORT OF THE ASSISTANT DEAN

Reminders – (1) The Graduate Open House is Monday, Oct. 8, 5:00-7:00 p.m. in the Apollo room. (2) The Graduate School is offering recruitment funding to assist graduate programs with new efforts. Applications may be submitted at any time.

Paper to Electronic Processes – With the graduate admissions workflow up and running, the Graduate School is beginning to look at other paper forms/processes that might be converted to an electronic process. Program input is welcome as the list is being compiled and prioritized.

The Policies Committee recommended, and the Graduate Council approved, language added to policy 2.23 that quantifies equivalent professional experience in situations when a terminal degree has not been obtained: *“Equivalent professional experience” shall normally consist of more than 5 years of professional-level work in the field for which the faculty member is being qualified.*

The Membership Committee reported on the graduate faculty members approved.

STUDENT AFFAIRS COMMITTEE

Minority Fellowship Awards – The committee has been given the charge to review candidates for the Wright Fellowship program aimed at attracting high quality underrepresented minority graduate students to WSU. Since there are funds available for 2012-2013, the Graduate School has begun a nomination process for 8 scholarships for Spring 2013. Graduate students who began Summer 2012, Fall 2012, or who will begin Spring 2013 will be eligible for the Spring 2013 awards. A separate nomination process will take place later in the academic year for 2013-2014. Up to 4 awards will be given to graduate students who begin Fall 2013. Each graduate program is encouraged to nominate one student for the award. The deadline is Oct. 30, 2012.

Alumni Awards – The call for nominations was emailed earlier this week; the deadline for nominations is Oct. 30, 2012. Each college should nominate one graduate alumnus.

IV. GRADUATE STUDENT ASSEMBLY

The GSA is actively working on membership recruitment and fundraising. The campus wide announcement for this fall's professional development and original work grants will be made on Nov. 5.

3. Report of the University President and Provost

President Hopkins

- Local nurses were recently honored at the Cameos of Caring, many of the honorees are WSU graduates and it was a very moving event.
- The COLA donor recognition event preceded our Holidays in the Heartland concert and honored those who support scholarship for our students. This was our 15th annual Holidays in the Heartland event.
- SSI – Governor Kasich has charged Ohio higher education with creating a new mechanism to replace the SSI. Five university presidents have been overseeing the development of a new formula under guiding principles from the Governor and that group must consider 14 institutions plus their 23 branch campuses. Two-year institutions have a separate panel working on their formulation. Under the new plan, there is no longer a stop-gap measure to prevent low funding but we are working very hard to be sure WSU will be well-rewarded under the new plan. The present SSI formula is weighted 20% for degree completion and 80% for course completion but it is proposed to be weighted 50% degree completion and 50% course completion. We don't yet know how transfer students will be treated. We hope the formula changes to provide proportional credit between the schools where a student starts and finishes. Out of state students are also being reformulated. How at-risk-students are weighted is also in discussion. Not all students begin at the same starting line and a proposal has been made to weight students based on specific risk factors. Additionally, college ready standards will also be discussed and we will work towards a resolution as to how at risk students are calculated in the SSI. Happily, the newly proposed formula currently correlates very well with our

mission and we will diligently work towards maintaining that. I'm so proud of what we do here at Wright State and the quality of our instruction and programs show we care and I thank you.

Interim Provost Sudkamp

- The President's group will adopt a state-wide remediation standards policy tomorrow.
- Four candidates for the COLA dean position will be on campus over the next few weeks with the goal of having someone in place in January.
- A new scholarship program is beginning soon with an aggressive campaign kick-off. College deans have been charged with developing recruiting campaigns for their colleges. We must work harder to "close the deal" and our faculty, programs and quality will convince potential students.
- An e-mail asking employees to pass along potential student's contact information so we may reach out to them was sent out. Please forward information regarding those students. All of our efforts will increase our yield and our goal is to make WSU the institute of choice for the region.

Faculty Budget Priority – On behalf of the Faculty Budget Priority Committee, Dan Krane met with the Council of Deans Tuesday, October 30, 2012 to discuss the university's budget model.

Participants agreed that the current budget model does not reflect the university's mission and that the root problem is that it also fails to consider differences in the cost of instruction between the colleges. The resulting 16% tax to move money from low cost instruction colleges to high cost instruction colleges is a poor solution.

In the near future, the Council of Deans will meet to consider an altered model where course credits (tuition dollars) will be weighted to reflect the differences in cost of instruction and a tax will be imposed to generate a \$7M strategic initiatives fund. This is approximately 1/7 of the current model's strategic initiatives fund, or about 3% rather than 16%.

Yearly taxing of the service units to create a strategic initiatives pool was well received by the Council of Deans and will be discussed at a subsequent meeting.

Once the varying cost of instruction is addressed the Council of Deans can then address other issues such as supporting matrix departments and incentivizing research, collaboration, and high quality instruction.

The Faculty Budget Priority Committee appreciates the opportunity give input to the administration and move toward a budget model that is both transparent and driven by WSU's mission.

Buildings & Grounds – The architectural team is now surveying the new Classroom Building site based on information we provided for them as to our needs and are also developing plans based on that information. The faculty liaison position for the Classroom Building is not a well-defined role and we are working towards keeping communication open. It is a time-consuming task to make sure faculty input is given and make sure we are abreast of decisions being made.
