ATTACHMENT A

The following questions were posed to Paul Hernandez, Director of CATS by the Information Technology Committee. Larry Fox, Associate Director of Technical Services, CATS, is on hand to answer any questions.

1) What is being done to resolve the lost email problem and what can be done to prevent similar problems from occurring in the future?

CaTS recommends that faculty, staff, and students use the Wright State email system for all official university email. Also, CaTS can add a dropbox service that is university branded.

2) Have any loss of email tickets issued by the help desk been closed? If so, were the people affected by those tickets contacted to ensure that the given solutions were adequate? Were those people involved in closing the tickets?

Yes, there have been tickets closed by the CaTS staff. There were no initial tickets just an email from Tom and Henry. The faculty/staff that were affected by the later tickets that were issued were involved in the ticket resolution.

3) What is the specific process CaTS employs to close tickets? Is there any auditing of satisfaction levels of those originating the tickets? Is there any auditing of tickets to ensure that problems are being solved, or are they being unilaterally closed out by junior personnel without the oversight of knowledgeable and responsible managers? Is there a need for a change to the process and/or procedure for closing tickets. If so, what should that new process be?

A ticket is closed when:

- a) A problem or request is resolved.
- b) A solution is not possible. Information is explained to the client and other suggestions may be made by the tech.
- c) Client calls and says the problem has fixed itself and the ticket should be closed.
- d) Client has been contacted at least 3 times with no respond back. Client is emailed the ticket number again and encouraged to contact the Help Desk if the problem is not resolved and should be reopened.

4) CaTS has, to the best of our knowledge, known of this problem since at least October 31. Although it is recognized that it may take some time to resolve the underlying issues, why has the WSU community not been made aware that the problem that exists so that individuals can take additional steps to ensure receipt of particularly important documents? If temporary workarounds are known, why have these not been communicated to the WSU community? CaTS routinely informs the WSU community about potential security risks. Why are they not warning the community about potential loss of data risks?

CaTS is currently in the process of an e-mail conversion to RaiderMail. Even prior to the conversion of the e-mail services CaTS would routinely receive support requests every week regarding e-mail issues and would work through those issues with the individuals. The initial problems identified were related to clients using e-mail services external to the university and our existing anti-spam services. This was mentioned in the initial "RaiderMail Update" with a link to additional details on a support web site. In no case did we find a loss of e-mail data related to the new Microsoft based e-mail services.

Graduate Council Report to the Faculty Senate
November 2012

The Wright State University Graduate Council met on November 1, 2012. Its standing committees met prior to that date.

I. REPORT OF THE DEAN

Graduate Open House – The fall Graduate Open House was held on Oct. 8 with 303 in attendance. 201 applications were received.

Program Reviews – The university has begun a discussion on program review in anticipation of the Higher Learning Commission of the North Central Association’s accreditation visit in 2015. An ad hoc committee has been formed to develop the process and procedures. The Graduate School met with the committee chair, Stephanie Davis, and discussed a uniform process for review with the masters’ programs and undergraduate programs. The review of the doctoral programs will continue as established last year.

Tuition Remission Policy – The Research Council approved a revised policy on fee remission for graduate research assistants. Two changes were made to the policy since it was last viewed by Graduate Council: (1) A lower requirement for the stipend was set which will help give flexibility to the colleges and faculty; and (2) New language was removed from the policy that permitted undergraduate students participating in combined degree programs to be eligible for fee remission.

II. REPORT OF THE ASSISTANT DEAN

The Graduate School has been working with a marketing firm in Columbus, Ologie Inc, which has extensive experience working with higher education. Over the last few months, Ologie has completed a situation analysis, based upon which they are developing a marketing strategy that includes a personality and message for the Graduate School. They have also provided a platform from which the Graduate School can market itself and adapt to market individual programs. This project is still a work in progress.

3. Report of the University President and Provost

President Hopkins

This week, a Dayton Daily News article reported on the outcomes of the recent meetings of the Ohio Higher Education Funding Commission. As part of the Commission along with other Ohio university presidents, our recommendations have gone forward to Governor Kasich and have been very well received. The Governor wants us to focus on degree completion and the new SSI formula does this. This is an improved formula and WSU will benefit tremendously and it will allow us to focus on our mission of educating all students.

Some of the changes include:

- Grouping funding for main and regional campuses together
- Reconsidering how out-of-state students are funded
- Awarding credit for associate degrees received at a four-year institution
- Removal of the stop-loss (there is no longer a minimum of how much funding a school can lose if they fail to meet their goals)
- STEM weights are retained
- Proportional credit for transfer students
- Weightings are changed for students with significant challenges

Interim Provost Sudkamp

Our mission is to meet the challenges of our students. Four factors are considered when weighting challenged students in the formula: academic, financial, age, and race. We

lobbied strongly for the new formula to also reward those schools whose goal is to provide for those students who have challenges as it matches our mission. We are not penalized because our mission does not only serve the top students.

President Hopkins

While not all schools benefited from the new formula, this is a positive move for both Wright State University and the State of Ohio. This new funding plan recognizes Wright State for what we do and do well. Governor Kasich promised to find additional funding for the formula if the Commission met his expectations. The Governor is the first step in the process, as the recommendations must move through the legislature.

Additionally, a recent Dayton Daily News article represented Wright State University and a local consultant we have used in an unfavorable light. We have carefully reviewed his contract and have seen nothing unethical. The article centered on research and intellectual property and we believe this was an unfortunate incident where this person's work was concerned and how it was interpreted.

Of the fifty states, we are seventh in research but last in commercialization of intellectual property. We have worked hard and invested to help our faculty grow commercialization of intellectual property since Robert Fyffe accepted the Vice President for Research and Graduate Studies position.

Interim Provost Sudkamp

I would encourage Senate to invite Dr. Fyffe to address them at a future meeting on the methods we have adopted for faculty to bring intellectual property forward for development.

Four candidates have been on campus for the COLA Dean Search. The search committee will be considering input from evaluations at its meeting on December 4.

Applications for the Provost position are currently being reviewed.

The Executive Committee met on November 19. While we approved the agenda for today's meeting, the majority of our time was spent discussing the recent issues centering on e-mail failures that occurred with the recent transition of our e-mail system. The Information Technology Committee submitted questions to Paul Hernandez, Director, CATS, and although he cannot be in attendance today, he submitted a written response to those questions which you have received. Larry Fox, Associate Director of Technical Services, CATS, is here to answer questions. - The university community should be notified that those are in use so individuals can make adjustments if they choose
- An announcement should be posted on the CATS bulletin board. An announcement has been made available on the "Known Issues" site
- The problem is with external senders masquerading as WSU accounts

- Turning off the Microsoft spam filter did not solve the issue
- You should only use a WSU e-mail account if you want to avoid problems
- This does not solve the problem with senders outside of WSU
- The issue will continue to be addressed with Paul Hernandez reporting back to Senate
