**3. Report of the University President or Provost**

**David R. Hopkins, University President**

Wright state has several major initiatives currently underway this spring.

**Branding Initiative:** The focus will be on 21st century higher education; to think strategically on how to position the university to be viewed by others in the community, stake holders, students and their families. Jim Munch and the Department of Marketing are currently working on this initiative for fall 2014; updates will be announced in April, 2014.

**Completion Plan:** Students arriving at colleges today are coming to the universities with different definitions of what they are trying to achieve and what their expectations are in obtaining a baccalaureate degree, associate's degree or certificate of completion. Wright State wants to ensure its students will be successful in reaching their expectations and is currently working on a completion plan to submit to the Board of Trustees at the April meeting; pending approval from the BOT the plan will be forwarded to the Ohio Board of Regents by June, 2014 as required.

**Capital Campaign:** Ms. Rebecca Cole Vice-President University Advancement will provide further information in her presentation to follow.

**Capital Bill:** Approval of the bill has been delayed until May, 2014 we hope. WSU should receive funding 90 days after approval. WSU is anticipating receipt of \$14.1M for maintenance and general projects at Main Campus and Lake Campus.

**Quality and Value Higher Education:** Governor Kasich has formed a group to make recommendations by June 2014 on how to improve the quality and value of Ohio higher education. I am pleased to serve on this group.

The Federal Government is currently developing a ranking system that would rate institutions on quality and value of higher education. It is anticipated by 2015, federal funds (Pell Grants) will be dispersed based upon some aspect of this ranking system. Ms. Jamie Studley, Under Secretary, U.S. Department of Education is tentatively scheduled to visit Wright State in April for a statewide town hall meeting.

Dan Krane invited President Hopkins to the March Senate Meeting to share a presentation of his vision of Quality and Value in Higher Education in the 21<sup>st</sup> Century.

#### **4. Report of the Senate Executive Committee**

##### **Dan Krane, Faculty President**

- A. Nominations are being accepted for Faculty Senators 2014-15 academic year until close of business on Friday, February 28, 2014.

Nominations for Vice-President will be accepted until close of business on Monday, March 10, 2014.

In April, Matt Rizki will assume the position of Faculty President for one year. During the transition period of the new faculty constitution and bylaws it is necessary to elect a Vice-President who will serve with President Matt Rizki during 2014-15. Thereafter, once the new bylaws are in full swing, both the faculty president and vice-president will serve two-year terms.

- B. Ohio Faculty Council is currently developing a white paper on the quality and value of higher education. Faculty are invited to provide their input and can submit feedback to Dan Krane prior to the March 14 OFC meeting. The paper will be submitted to Chancellor John Carey and Board of Regents through the OFC.

on the desirability of awarding associates degrees and consider the most appropriate way for Wright State to develop the degrees if they choose to offer them. The recommendations are to be presented to the Executive Committee prior to its March 10, 2014 meeting for report to the Faculty Senate meeting on March 17, 2014.
