**3. Report of the University President and Provost**

**Sundaram Narayanan, Provost**

- Dean Bonnie Mathias plans to retire at the end of the 2014-15 academic year. Dean Kristin Sobolik will chair the search committee for the Dean of Lake Campus.
- Associate Provost Steven Berberich has been appointed to chair the search committee for a Chief Information Officer.
- An expansion of the parking lot near the Neuroscience Engineering Collaboration Building is planned to be ready for use spring 2015.

**David R. Hopkins, University President**

- President David R. Hopkins thanked the Senators for their service this past year. President Hopkins also took a moment to thank Faculty President Dan Krane for his dedication to the Faculty Senate and congratulated him for breaking the record of chairing the most consecutive Faculty Senate Meetings.

- Congratulations to Faculty President Dan Krane for being named an American Council of Education (ACE) Fellow. Faculty President Krane was among 31 fellows selected from a pool of 1,000 applicants and is the first member of the WSU Faculty to be selected for this fellowship.
- State of Ohio, Mid-Biannual Budget Review – Faculty Workload Resolution:  

WSU Faculty Workload Resolution and the OFC Workload Resolution were accepted. The HB 472 and Resolution are now at the Ohio Senate for review without the 10% faculty workload provision. President David R. Hopkins recognized State Representative Cliff Rosenberger a WSU Graduate and former Model UN Student for his assistance with this matter.
- Quality and Value of Higher Education:

The demographics of today's college students has changed in the 21<sup>st</sup> Century, 75% of the 20 million students enrolled in our national colleges and universities are non-traditional. Today's college students are arriving with a different definition of what they are trying to achieve and what their expectations are in obtaining a baccalaureate degree, associate's degree or certificate of completion. These students are arriving at universities with different levels of college readiness and backgrounds. In an effort to reach these students and ensure they reach the finish line, President Hopkins encouraged the Faculty Senate to think differently with regards to the 21<sup>st</sup> Century in Higher Education and the challenges that must be embraced if we are going to be a relevant institution in the 21<sup>st</sup> Century.

##### **Dan Krane, Faculty President**

- A. Faculty President Dan Krane reviewed the accomplishments of the Faculty Senate Committees this past 2013-14 academic year. Much of the success can be contributed to the realignment of the Undergraduate Curriculum Committee. The realignment of these committees allowed the Senate to focus their time and attention to other matters such as: The Research Council evaluating the way research misconduct is handled; the IT Committee recommendations resulted in a search for Chief Information Officer; Buildings and Grounds Committee played an important role in the university's capital funding from the State of Ohio. C. Ohio Faculty Council (OFC) Resolutions:

- I. The Workload Resolution (HB 472) was passed by the OFC to include the recommended changes to remove the 10 percent increase in faculty workload as suggested by the Faculty Senate. Another portion of the bill that requires state universities to evaluate their faculty workload, workload policies and submit a report to the Chancellor by the end of the upcoming year will remain in the bill as proposed. The OFC plans to assist the Chancellor with review, collection and evaluation of the reports.

- II. College Credit Plus (HB487) creates a more uniform system for dual enrollments and for granting college credit for AP classes that students have in high school; facilitates continuing education for high school instructors to better deliver this content to students. Senator Garber thanked President David R. Hopkins for his vision and his service on the Quality and Value White Paper. Senator Garber encouraged fellow senators to seek out high school graduates and talk to them about college. Senator Garber stressed that we cannot go on with business as usual; we need to encourage high school students to continue their education.

Senator Pollock noted that no amount of work at the college level could undo students not being prepared for college; this needs to be done prior to their arrival on campuses. Focus could be placed on Colleges of Education to prepare teachers at the high school level in teaching students.

April 15, 2013, the Faculty Senate accepted the Tobacco Policy Taskforce Ad hoc Committee's report and recommendation to charge the University Administration with the task of investigating the possibility of the campus becoming a tobacco free environment.

The University Cabinet accepted the findings of the report and is ready to draft a Wright Way Policy for the university to become a tobacco free environment. Over the course of the summer, faculty will be able to provide input with regards to the policy and implementation of the policy as noted in the recommendations.

Faculty President Dan Krane thanked Steve Farrell and the Taskforce for their work. The Administration may ask the Faculty Senate to review a draft of an update to the Wright Way Policy on smoking in the fall.

Jeff John presented an overview of the Athletics Council activities during the 2013-14 academic year. The Athletics Council has met a total of eight times and on one occasion, hosted President David R. Hopkins as a representative of the NCAA Executive Committee.

Academic Affairs Committee reported on the use of Pilot and the elimination of the need to send out the green and yellow academic card for athletes. The athletes have a 78 percent graduation rate with a GPA of 3.1 or above.

An ad hoc committee of the Athletics Council organized two pre-game lectures that each brought approximately 100 people to hear WSU faculty describe their research and honor our student athletes prior to two men's basketball games.

Student Welfare Committee reported they have converted from separate team and athlete exit survey to a single exit survey. The results of these surveys show a general satisfaction with the programs and facilities.
